





**FIRST AMENDMENT TO
INTERLOCAL AGREEMENT BETWEEN
KING COUNTY AND THE KING COUNTY FLOOD CONTROL ZONE DISTRICT
REGARDING SUPPORT SERVICES**

THIS FIRST AMENDMENT to the “Interlocal Agreement Between King County and the King County Flood Control Zone District Regarding Support Services” (“Agreement”) is entered into by KING COUNTY, a home rule charter County in the State of Washington (“County”) and KING COUNTY FLOOD CONTROL ZONE DISTRICT, a quasi-municipal corporation of the State of Washington (“District”) and shall be effective upon execution by both Parties.

RECITAL

The Parties desire to amend the Agreement to authorize advance payments for services pursuant to RCW 42.24.080.

AMENDMENT

1. The Parties agree to add a new paragraph 2.5 to the Agreement as follows:

Pursuant to RCW 42.24.080, the District, acting through either its Executive Committee or the Board of Supervisors, may, upon request of the County, approve an advance payment to the County for services under this Agreement.

2. The Parties agree to add a new paragraph 3.9 to the Agreement as follows:

Pursuant to RCW 42.24.080, the County may request the District to approve an advance payment for services under this Agreement. Upon request of the District Executive Director, the County shall provide information to support such request.

IN WITNESS WHEREOF, the Parties have caused this First Amendment to be executed by their authorized representatives.
