Dear Councilmember Phillips:

The King County Economic Opportunity and Empowerment Program Advisory Board is established by ordinance 17973. The purpose of this 12 member board is to support the Program's administrator in developing a plan to help boost the number of minority, women, veteran, and youth workers on the Children and Family Justice Center project to replace the outmoded Youth Services Center.

Per King County Code, Board members will serve staggered terms with one-third serving a one-year term, one-third serving a two-year term, and one-third serving a three-year term. Upon successfully completing their initial term all members will be eligible for reappointment to a full three-year term. Board membership includes representatives from the building trades, construction industry, labor, coalition and community organizations, pre-apprenticeship training providers, and others.

Construction on the replacement for the Youth Services Center in Seattle's Squire Park neighborhood is expected to begin in 2016.
