METRO-KING COUNTY COUNCIL has a public hearing before the Metropolitan King County Council on the proposed ordinances 2024-010 and 2024-011, to amend and repeal Ordinance 2023-010 and 2023-011 which would amend the Comprehensive Plan, Planning Policies and Code for the County of King. The Comprehensive Plan (CP) is the County's primary policy document that sets the long-term vision and strategy for the County. The CP is updated every five years and is the foundation for all other County policies and codes. The proposed ordinances would amend the CP to reflect the latest planning and development trends and to ensure consistency between the CP and other County policies and codes. The proposed ordinances would also amend the Comprehensive Plan to address the needs of the County's diverse communities and to promote sustainable and equitable growth.
