**STATEMENT OF FACTS:**

1. A notice of intention proposing the annexation of an area known as

Dahlgren (98-1) Annexation Area to Sammamish Water and Sewer

District for water service was filed with the county council effective April

11

20, 1998.

2. Sammamish Water and Sewer District has found the petition for

13

annexation to be sufficient and has concurred with the proposed

14

annexation in Resolution No. 2455 filed on June 14, 1999.

3. Sammamish Water and Sewer District filed a Determination of

16

Nonsignificance on the proposed annexation dated November 16, 1998.

4. The Utilities Technical Review Committee recommended county

18 council approval of the proposed annexation on April 11, 1999.

19 5. The county council held a public hearing on the day of August 30,

20 1999 and has considered the criteria set forth in RCW 57.02.040.

21 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

22 SECTION 1. The annexation by Sammamish Water and Sewer District of the  
23 area known as the Dahlgren (98-1) Annexation Area and described in Attachment A is  
24 approved. This proposed annexation is consistent with RCW 57.02.040.

25 SECTION 2. Sammamish Water and Sewer District is the appropriate entity to  
26 serve the area proposed to be annexed.

27 SECTION 3. Completion of this annexation does not constitute county approval

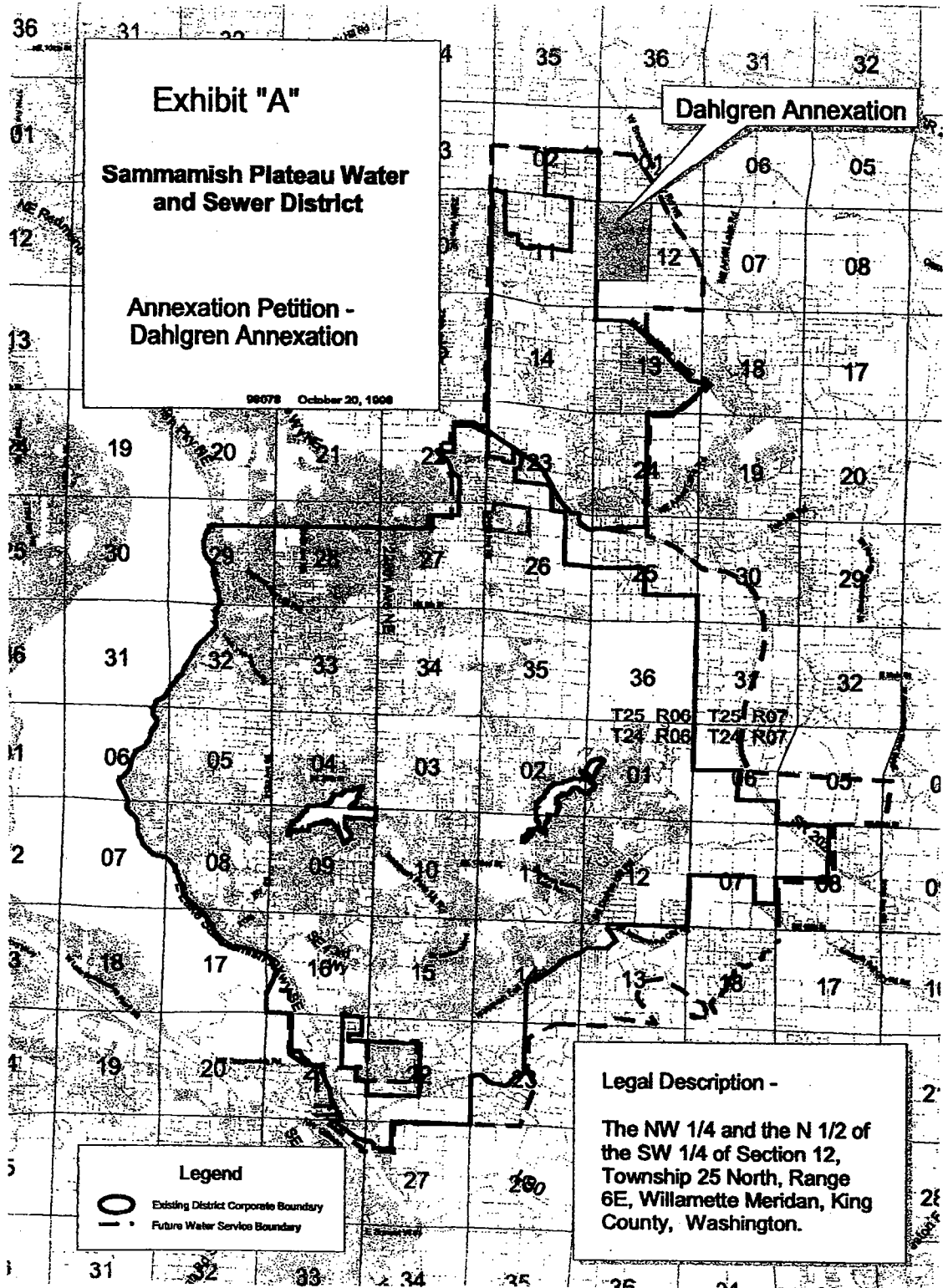
