1 AN ORDINANCE authorizing the King County executive  
2 to enter into amendments to interlocal cooperation  
3 agreements with the cities of Bellevue, Burien, Federal  
4 Way, Issaquah, Kent, Kirkland, Newcastle, Renton,  
5 Sammamish, Seattle, Shoreline and Tukwila for the  
6 disbursement of conservation futures tax levy funds  
7 appropriated under Ordinance 15975.

9 **STATEMENT OF FACTS:**

- 10 1. Conservation futures tax levy funds are collected throughout King  
11 County as a dedicated portion of the property tax for the acquisition of  
12 open space and resource lands.
- 13 2. Ordinance 14714 established procedures for the annual allocation of  
14 conservation futures tax levy funds, which directs the conservation futures  
15 citizens committee to make funding recommendations to the King County  
16 executive to consider for inclusion in the annual budget ordinance.
- 17 3. The executive has received and considered the conservation futures  
18 citizens committee funding recommendations in his transmittal of the

19 annual budget ordinance, and the King County council has appropriated  
20 2008 conservation futures funds by Ordinance 15975, to the city open  
21 space projects listed and described in Attachment B to this ordinance.

22 4. The county desires to disburse conservation futures funds to the city of  
23 Seattle and suburban cities, and must do so by amending existing  
24 conservation futures interlocal agreements with these jurisdictions.

25 5. The county and the cities are authorized to enter into an interlocal  
26 agreement pursuant to chapter 39.34 RCW, the Interlocal Cooperation  
27 Act.

28 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

29 SECTION 1. The King County executive is hereby authorized to enter into and  
30 execute amendments to interlocal cooperation agreements, containing language  
31 substantially similar to that attached, necessary for the disbursement of conservation

32 futures tax levy funds appropriated under Ordinance 15975, as adopted by the King  
33 County council.







**AMENDMENT TO THE CONSERVATION FUTURES  
INTERLOCAL COOPERATION AGREEMENT  
BETWEEN KING COUNTY AND THE CITY OF \_\_\_\_\_  
FOR OPEN SPACE ACQUISITION PROJECTS**

**Preamble**

The King County Council, through Ordinance 9128, has established a Conservation Futures Levy Fund and appropriated proceeds to King County, the City of Seattle and certain suburban cities. This amendment is entered into to provide for the allocation of additional funds made available for open space acquisition.

THIS AMENDMENT is entered into between the CITY OF \_\_\_\_\_ and KING COUNTY, and amends and attaches to and is part thereof of the existing Interlocal Cooperation Agreement entered into between the parties on the \_\_\_\_ day of (Month), (year), as previously amended.

The parties agree to the following amendments:

**Amendment 1: Article 1. Recitals**

A paragraph is hereby added to the Recitals Section to provide for a Conservation Futures Levy Fund allocation for the \_\_\_\_\_ Acquisition, and hereafter reads:

**Amendment 3: Article VII. Responsibilities of County**

The first two sentences of this article are amended to include references to Attachment \_\_, which lists a 200\_ Conservation Futures Levy proceeds allocation for the \_\_\_\_\_ Acquisition Project:

Subject to the terms of this agreement, the County will provide Conservation Futures Levy Funds in the amounts shown in Attachments A through \_ to be used

for the Projects listed in Attachments A through \_\_. The City may request additional funds; however, the County has no obligation to provide funds to the City for the Projects in excess of the total amounts shown in Attachments A through \_\_. The County assumes no obligation for the future support of the Projects described herein except as expressly set forth in this agreement.

**AMENDMENT 4: Attachment \_\_**

The Attachments to the interlocal agreement are hereby amended by adding Attachment \_\_, which is hereby attached to the interlocal agreement, incorporated therein, and made a part thereof.

In all other respects, the terms, conditions, duties and obligations of both parties shall remain the same as agreed to in the Interlocal Cooperation Agreement as previously amended.

This document shall be attached to the existing Interlocal Cooperation Agreement.

## 2008 Conservation Futures (CFT) Project Descriptions

### Seattle CFT Projects:

#### **315434 University District Urban Center Park**

The goal of this project is to acquire open space for Seattle's University District. This project previously received CFT funds as a half share of Seattle's "U District/Denny Triangle Urban Center Park" 2003 CFT Project, the goal of which is to provide additional open space in the rapidly growing, high density neighborhoods of the University District, and the Denny Triangle adjacent to downtown Seattle. The 2003 University District CFT project requires Seattle to formally propose such a site and it has proposed this site. Seattle will need to meet the non-impervious surface requirements of the CFT program as it develops its open space on the site.

#### **315435 East Capitol Hill Urban Center Park**

This project consists of the acquisition of property at 16<sup>th</sup> Avenue and East Howell Street in the East Capitol Hill neighborhood, near the 15<sup>th</sup> Avenue commercial district in Seattle.

#### **315436 Kiwanis Ravine Greenspace**

This project consists of acquisition of addition land for Kiwanis Ravine in the Magnolia neighborhood of Seattle, home of a Great Blue Heron colony.

#### **315437 Longfellow Creek Greenspace**

This project consists of the acquisition of a wooded inholding property within Seattle's Longfellow Creek Greenspace.

#### **315438 Westlake Greenbelt**

This project consists of the acquisition of an inholding in the West Lake Greenbelt, located near 8<sup>th</sup> Avenue North in the Queen Anne neighborhood of Seattle.

#### **315439 Chinatown / Int'l District Urban Center Park**

This project will expand an existing park in the Chinatown/International District area of Seattle's "Downtown Urban Center" on South King Street.

### Suburban City CFT Projects:

#### **315767 BEL - Bellevue Greenway and Open Space System**

Bellevue has targeted several parcels that will help connect the city's greenway and open space system, with this year's top priority being a parcel south of Interstate 90 that improves the connection between Cougar Mountain Regional Wildland Park and Cold Creek Park. A second priority is an inholding property in the Mercer Slough Park.

## 2008 Conservation Futures (CFT) Project Descriptions

### **315768 BUR - Seahurst Park Expansion**

This project consists of the acquisition of a 9.11-acre wooded open space addition to the southern boundary of Seahurst Park, located in Burien at 18th Avenue Southwest.

### **315769 FED - Camp Kilworth Forest and Nearshore**

This project consists of the acquisition of Camp Kilworth is a 25-acre, wooded property on Puget Sound, located on SW Dash Point Road in Federal Way.

### **315770 ISS - Issaquah Creek Waterways**

This is a multiple-property habitat preservation project along Issaquah Creek in Issaquah, which will preserve riparian and salmonid habitat and will help link together permanently preserved city-owned open space on the creek.

### **315771 KNT - Desimone and Lotto (Green River)**

The goal of this project is to acquire inholding parcels of land on and near Mullen Slough on the lower Green River in Kent.

### **315772 KNT - Panther Lake**

This project will acquire open space on Panther Lake for public access and habitat preservation. The project is located in unincorporated King County northeast of Kent in Kent's urban annexation area.

### **315773 KRK - Yarrow Bay (Irvin)**

This project will acquire a wooded buffer property adjacent to Kirkland's Yarrow Bay Wetlands Park, a preserve located on Lake Washington just north of State Route 520.

### **315774 NEW - May Creek Entrance**

This project consists of the acquisition of a wooded parcel that is missing link in the May Creek Trail in Newcastle. A portion of the property may also serve as a trailhead that provides safe access to the May Creek trail.

### **315775 REN - May Creek Trail Corridor**

This project consists of acquiring wooded parcels contiguous to public land in the May Creek corridor to help complete protection the May Creek Park system, east of I-405 in Renton.

### **315776 SAM - Sammamish Landing**

This project consists of the acquisition of "missing link" park inholding parcels on the north east shore of Lake Sammamish. A major goal of the project is to both protect and to allow for improved management of the natural shoreline of the northeast shore of the lake, as well as provide limited public access to the lake from the adjacent East Lake Sammamish Trail.



## 2008 Conservation Futures (CFT) Project Descriptions

### **315777 SHO - Krukeberg Property**

This project consists of the acquisition of an existing botanical garden located in Shoreline's Richmond Beach community.

### **315778 SHO - South Woods Addition II**

This project consists of the acquisition of up to 15.6-ares of second growth conifer forest located at 25th Avenue NE and NE 150th Street, immediately south of Shorecrest High School in Shoreline.

### **315779 TUK - Duwamish Gardens**

This project consists of the acquisition of land located on the Duwamish River near East Marginal Way South in Tukwila. The project goal is to acquire the site for restoration as intertidal habitat for salmon and aquatic species.
