NOTICE IS HEREBY GIVEN that the Metropolitan King County Council held a public hearing in the Council Chambers on the 10th Floor of the King County Courthouse (516 Third Avenue, Seattle Washington) on Monday, the 23rd day of November, 2015 at 1:30 p.m. The purpose of this public hearing was to consider adoption of Proposed Ordinance 2015-0398 (Ordinance 18183), modifying the code provisions for transmittal of school capital facility plans and the capital improvement plan.

SUMMARY

Ordinance 18183 modifies the transmittal deadline for school capital facility plans and the capital improvement plan, to allow for annual amendments during the mid-biennial review of the budget.
