However, through no fault of mine and without any way to realize the County had made an input error of the square footage in the 1980's, I have been paving taxes on over 850 square feet of property I don't even have for over 20 years! Since there is no designation of square footage on the notice of change in valuation, I had no way of realizing there had been an error until I had my house appraised for a refinance in 2002. The appraiser recommended I call your office about it, which I did, but your representative told me on the phone that there was no error and that garage space as well as my tri-level home with open cathedral ceiling space all counted as 2 story living floor space.

Per my telephone call with David Goff today, I am returning the signed form to Board of Equalization (enclosed), but I am requesting a correction on the Manifest Error for prior years. I understand that 20 years of overpayment amounts to a substantial injustice and respectfully request the County to provide me with tax credits or whatever is legally available to make an accommodation
