### Ordinance 18238

1 AN ORDINANCE adding the vice chair of the budget and  
2 fiscal management committee and the vice chair of the law  
3 and justice committee to the list of persons eligible to be  
4 appointed to the leadership group of the E-911 strategic  
5 plan scoping committee; and amending Ordinance 18139,  
6 Section 2.

7 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

8 SECTION 1. Ordinance 18139, Section 2, is hereby amended to read as follows:

9 A. The leadership group of the E-911 strategic plan scoping committee will  
10 finalize the recommendations to be included in the report. These recommendations shall  
11 be made by consensus, to the extent possible. In the absence of consensus, each member  
12 shall have one vote unless otherwise noted in this section.

13 The leadership group shall consist of:

- 14 1. Three King County councilmembers, consisting of the chair or vice chair of  
15 the budget and fiscal management committee, the chair or vice chair of the law((;)) and  
16 justice ((and emergency management)) committee and the council vice chair of regional  
17 coordination, or their successors;
- 18 2. Two city of Seattle councilmembers, recommended by the city of Seattle;
- 19 3. Three elected officials recommended by the Sound Cities Association;

- 20           4. One Bellevue councilmember, recommended by the city of Bellevue;
- 21           5. One fire district elected commissioner designated by the King County
- 22 Council in the appointing motion;
- 23           6. The King County sheriff;
- 24           7. The King County executive;
- 25           8. One representative of public safety answering points ("PSAPs")
- 26 recommended by Valley Communications and NORCOM;
- 27           9. One representative of the PSAPs recommended by the city of Bothell, city of
- 28 Enumclaw, city of Issaquah, Port of Seattle, city of Redmond, University of Washington
- 29 and Washington State Patrol;
- 30           10. One representative of the PSAPs recommended by the city of Seattle; and
- 31           11. One representative of the E-911 program office, recommended by the
- 32 executive, to be the nonvoting ex officio member and technical advisor to all committee
- 33 deliberations.

34           B. The council shall appoint the members of the leadership group by motion.

35 ~~((Within 14 days of the effective date of this ordinance the recommending agencies shall~~

36 ~~transmit an electronic copy of their appointment recommendations to the clerk of the~~

37 ~~Council, who shall retain the original and provide an electronic copy to the chair of the~~

38 ~~Council.))~~ In the appointment of leadership group members, the King County council

39 should strive to balance the geographic distribution of members, including specific

40 representation for the unincorporated areas of King County.

41           C. The leadership group shall transmit a progress report to the King County

42 council by March 31, 2016, identifying the committee's decisions to date and work

43 remaining before completion of the strategic planning process report. The report shall be  
44 filed in the form of a paper original and an electronic copy with the clerk of the council,  
45 who shall retain the original and provide an electronic copy to all councilmembers and


