METROPOLITAN KING COUNTY COUNCIL NOTICE OF PUBLIC HEARING

Ordinance 19122

NOTICE IS HEREBY GIVEN that a public hearing will be held before the Metropolitan King County Council, on August 18, 2020 at 1:00 p.m., to receive public testimony relating to Ordinance 19122, which adopted findings in support of and adopted for six months a moratorium prohibiting the establishment of new or expansion of existing wineries, breweries, distilleries and remote tasting rooms, prohibiting acceptance of permit applications for temporary use permits for such uses, and requiring the executive to study and develop a plan to address the issues and circumstances necessitating the moratorium. The public hearing is planned to either be held at the King County Courthouse, 516 3rd Avenue, Room 1001, Seattle, Washington; or the hearing may be required to be held remotely to comply with the Washington State Governor's Declaration 20-28 (or as amended) regarding the Open Public Meetings Act. Information on this public hearing, including how to submit public testimony and attend the meeting, will be posted on the Council's website ahead of the hearing.

Background

Ordinance 19122 was adopted on June 23, 2020. A public hearing within sixty days of the enactment of a moratorium and the adoption of findings is required by RCW 36.70A.390. This hearing is an opportunity for public testimony on the moratorium.
