NOTICE IS HEREBY GIVEN, that a public hearing before the Metropolitan King County Council will be held at the King County Courthouse, 516 3rd Avenue Room 1001 on the 27th day of June, 2023, at 1:30 p.m. to receive public testimony related to Proposed Ordinance 2023-0099. Remote public testimony on Zoom will also be accepted. Proposed Ordinance 2023-0099 would modify the Council's role in permit review process, by removing an option for an appeal to Council for many permit types, including preliminary plat and special use permits. The Proposed Ordinance would also make changes to the Hearing Examiner's section of code to reflect current practice and address known issues.
