21           WHEREAS, the committee has developed a work plan for 2011 to facilitate its  
22 review and development of policy options and recommendations on these and other  
23 issues, and

24           WHEREAS, the committee seeks full council support for its work program:

25           NOW, THEREFORE, BE IT MOVED by the Council of King County:




