7	County ("Interlocal Agreement") to provide technical expertise and services to
8	effectively and efficiently provide passenger-only ferry services to the people of the
9	county; and
10	WHEREAS, on April 27, 2009, the District adopted Resolution FD2009-04,
11	which approved an addendum to the Interlocal Agreement to authorize the county to
12	perform technical studies and develop a plan for demonstration route implementation;

14	WHEREAS, on October 25, 2010, the District adopted Resolution FD2010-20.1,
15	which approved a second addendum to the Interlocal Agreement to extend the period of
16	the Interlocal Agreement; and

THIS THIRD ADDENDUM TO INTERLOCAL AGREEMENT BETWEEN KING COUNTY AND THE KING COUNTY FERRY DISTRICT REGARDING ADMINISTRATIVE AND SUPPORT SERVICES (this "Third Addendum") is hereby entered into by and between KING COUNTY, a home rule charter County in the State of Washington (the "County") and the KING COUNTY FERRY DISTRICT, a municipal corporation of the State of Washington (the "District"), and shall be effective upon approval by the County and the District (collectively referred to as the "Parties").

WHEREAS, the County formed the District, in accordance with RCW 36.54.110 et seq., by adopting Ordinance 15739; and

WHEREAS, the Parties entered into the Interlocal Agreement Between King County and the King County Ferry District Regarding Administrative and Support Services, dated

effective May 23, 2008, and regarding the operation of ferry service (the "Ferry Service Interlocal"); and

WHEREAS, the Ferry Service Interlocal is in effect until December 31, 2011; and

WHEREAS, the Parties desire to extend the Ferry Service Interlocal for one more year and to amend the Ferry Service Interlocal accordingly;

NOW, THEREFORE, the following terms, conditions and covenants are hereby incorporated into, and made a part of, the Ferry Service Interlocal:

1. <u>The Parties agree to amend paragraph 9.1</u> to the Ferry Service Interlocal to read as follows:

This Agreement shall take effect upon its signing by both parties and shall remain in effect until December 31, 2012.

- 2. <u>Effective Date</u>. This Third Addendum shall take effect upon its signing by both parties.
- 3. <u>No Further Amendments or Additions</u>. Except as specifically amended by this Third Addendum, the Ferry Service Interlocal remains un-amended and in full force and effect.
