SUBJECT

Proposed Motion 2013-0020 would confirm Poppi Handy to the Landmarks Commission to fill the preservation architect position.

BACKGROUND

In 1980, King County established the Landmarks Commission to ensure preservation of the region's historic places, material culture and traditions for future generations.

The nine-member citizen commission is comprised of volunteers with a broad set of expertise in areas such as architecture, art, land use, historic preservation, archaeology, education and history. No more than four members may reside within any one municipal jurisdiction.

Commissioners are responsible for the designation and regulation of landmark properties, representation of suburban cities with interlocal agreements with King County, and advising the Executive and Council on King County landmarks issues. The Landmarks Commission promotes and protects historically significant sites by providing technical assistance to owners of historic buildings, community organizations and local public agencies. Additional responsibilities include oversight of cultural facilities, educational programs, special projects and sustained support programs that provide grants to landmarks organizations and individual specialists. Funding for landmark programs is available from the Cultural Development Fund, generated by hotel-motel tax revenues.

LANDMARKS COMMISSION CANDIDATE:

Poppi Handy Ms. Handy has worked extensively with nonprofit housing providers on the creation of affordable and sustainable housing projects. She is currently an Associate Principal with SMR Architects. She has been with that firm since 2000, and has progressed through a series of increasing responsibilities. She has been previously employed by John McLaren and Associates (1998-2000); Hochstrasser and Hoover Architects (1997-1998); and E. Lynn App Architects (1996-1997). She is a member of the American Institute of Architects, and is a steering committee member of the AIA Seattle Committee on the Environment. She served as the Conference Chair of the "What Makes It Green" AIA Conference in 2008.

Ms. Handy received a Bachelor of Architecture and a Bachelor of Science in Environmental Design degrees in 1997, both from Ball State University in Muncie, Indiana.

Ms. Handy has been the recipient of numerous honors and awards, including the SHPO Valerie Sivinski Award for Historic Preservation (2007), the NAHRO Agency Award of Merit (2007), and the NAHRO National Award of Excellence (2003).

Ms. Handy is being appointed to the preservation architect position on the Commission for a partial term, expiring June 1, 2014.
