

Levy Purposes

Paramount Purpose



CRISIS CARE CENTERS

Establish and operate a regional network of five crisis care centers in King County, with at least one in each of the four crisis response zones and one serving youth.

Supporting Purpose 1



RESIDENTIAL TREATMENT

Restore the number of mental health residential treatment beds to at least 355 and expand the availability and sustainability of residential treatment in King County.

Supporting Purpose 2



COMMUNITY BEHAVIORAL HEALTH WORKFORCE

Increase the sustainability and representativeness of the behavioral health workforce in King County.

Mobile Crisis Teams for Adults Have Added 10 New Teams Countywide


- Anyone can now call 988 and get a specialty behavioral health team to respond

Estimated Implementation Timeline





- **Host Community Conversations** in Spanish, Somali, Hindi, plus additional languages, educating on crisis services (Q1-Q3, 2025)
