1	A MOTION authorizing the chair of the council to enter
2	into a contract for consultant services to conduct an
3	independent and comprehensive audit of the elections
4	section of the King County records, elections and
5	licensing services division.

8	WHEREAS, the metropolitan King County council recently passed Motion
9	12107, calling for an independent and comprehensive audit of the elections section of the
10	King County records, elections and licensing services division, and
11	WHEREAS, the county's procurement services office issued a request for
12	proposal ("RFP") to conduct this audit, incorporating the requirements set out in Motion
13	12107, and,
14	WHEREAS, a technical evaluation committee, comprised of county council staff,
15	county auditor staff and the Multnomah county auditor, evaluated the proposals,

16	conducted interviews and determined that the proposal from The Election Center best
17	meets the selection criteria outlined in the RFP, and
18	WHEREAS, Motion 10651, Section III, as amended, and OR 1-020 requires the
19	council to authorize the council chair to sign any contracts in excess of twenty-five
20	thousand dollars;
21	NOW, THEREFORE, BE IT MOVED by the Council of King County:
22	The chair of the metropolitan King County council is authorized to enter into a
23	contract, in an amount not to exceed three hundred fifty thousand dollars with The
24	Elections Center to conduct an independent and comprehensive audit of the elections
25	section of the King County records, elections and licensing services division, that will at
26	least include a comprehensive examination of the following topics:
27	A. Incidents of previously uncounted ballots found after certification of an
28	election.
29	B. Incomplete, incorrect or missing signature images in the voter registration
30	database.
31	C. Procedures for tracking notification of felon convictions, cancellation of said
32	felons' voter registration and retention of notification and cancellation records.
33	D. Reconciliation of the number of votes cast with the number of voters credited.
34	E. Preparation and documentation of the Mail Ballot Report produced during
35	certification of elections.
36	F. Provisional ballots fed directly into the Accuvote machines without being
37	verified and the possibility of multiple voting.
