1 AN ORDINANCE approving the transfer of indirect
2 control of cable franchise 5602 from Radiate Holdings,
3 L.P., to Stonepeak Associates IV, LLC.

4 **STATEMENT OF FACTS:**

5 1. WaveDivision I, LLC, d/b/a Wave Broadband, a Washington limited
6 liability company ("franchisee"), owns, operates and maintains a cable
7 television system in King County rights of way under cable franchise
8 5602.

9 2. Under cable franchise 5602, franchisee serves approximately one
10 thousand customers in the unincorporated north and northeast areas of
11 King County.

12 3. Franchisee is a subsidiary of Radiate Holdings, L.P., a Delaware
13 limited partnership.

14 4. In accordance with an October 31, 2020 Agreement and Plan of
15 Merger, Stonepeak Associates IV, LLC, a Delaware limited liability
16 company, will assume indirect control of Radiate Holdings, L.P., and its
17 subsidiaries, including franchisee. After closing, Stonepeak Associates
18 IV, LLC, itself will be indirectly owned and controlled by separate
19 business entities that are ultimately owned and controlled by Stonepeak

20 Infrastructure Partners. Franchisee will continue to remain an indirect,
21 wholly owned subsidiary of Radiate Holdings, L.P.

22 5. Radiate Holdings, L.P., and Stonepeak Infrastructure Partners, have
23 requested King County's consent to the transfer of control in the franchisee
24 in accordance with the requirements of the cable franchise and have filed a
25 Federal Communications Commission Form 394, and related exhibits,
26 with the King County office of cable communications describing the
27 proposed sales transaction and Stonepeak Associates IV, LLC's technical
28 and financial qualifications.

29 6. Upon closing, franchisee will continue to hold cable franchise 5602.
30 Franchisee will also continue to provide cable service to county customers
31 without interruption. Franchisee has no changes planned to the current
32 terms and conditions of service or operations of the cable system.

33 7. K.C.C. 6.27A.010.CC. defines a "transfer" in part to mean "any
34 transaction in which: 1. an ownership or other interest in a franchisee is
35 transferred from one person to another person so that control of the
36 franchisee is transferred, or 2. the rights held by the franchisee under a
37 franchise agreement are transferred or assigned, in whole or in part, to
38 another person."

39 8. K.C.C. 6.27A.050.E. states that "[a]n application for approval of a
40 transfer of a franchise must contain, at minimum, information regarding
41 the applicant's technical and financial ability to construct and operate the
42 system and a statement that the proposed transferee will comply with the

43 transferor's franchise agreement, this chapter, the cable rules and
44 applicable law."

45 9. The office of cable communications retained an independent consultant
46 to evaluate the financial qualifications of Stonepeak Associates IV, LLC
47 and related business entities involved in the sales transaction. The
48 consultant concluded that Stonepeak Associates IV, LLC, has the financial
49 capability to provide the needed funding for the franchise.

50 10. Stonepeak Associates IV, LLC, has the technical ability to construct
51 and operate the cable system in authorized by franchise 5602. As stated in
52 the application for approval of transfer, franchisee's cable system will
53 continue to be operated by franchisee's existing technical and operational
54 personnel.

55 11. In accordance with section 4(e) of the franchise agreement,
56 incorporated by reference in franchise 5602, Stonepeak Associates IV,
57 LLC, certifies that it will comply with the terms of the franchise
58 agreement, the cable ordinance and applicable law.

59 12. Based on its evaluation of the information in Federal Communications
60 Commission Form 394 and the conclusions of the financial consultant, the
61 office of cable communications recommends approval of the transfer of
62 control of franchise 5602 from Radiate Holdings, L.P., to Stonepeak
63 Associates IV, LLC.

64 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

65 SECTION 1. The transfer of indirect control of franchise 5602 from Radiate

66 Holdings, L.P., to Stonepeak Associates IV, LLC, is approved. The approval shall not
67 waive or release any rights of the county under the franchise agreement or applicable law,
68 including those arising before the effective date of the transfer of control, nor in any way

69 relieve WaveDivision I, LLC, of its obligation to adhere to the requirements of the
70 franchise agreement and applicable law.



ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Carahsoft OBO King County ITD (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign, Inc. (DocuSign) electronic signing system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to these terms and conditions, please confirm your agreement by clicking the 'I agree' button at the bottom of this document.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after signing session and, if you elect to create a DocuSign signer account, you may access them for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

Consequences of changing your mind

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. To indicate to us that you are changing your mind, you must withdraw your consent using the DocuSign 'Withdraw Consent' form on the signing page of a DocuSign envelope instead of signing it. This will indicate to us that you have withdrawn your consent to receive required notices and disclosures electronically from us and you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.

All notices and disclosures will be sent to you electronically

Unless you tell us otherwise in accordance with the procedures described herein, we will provide electronically to you through the DocuSign system all required notices, disclosures, authorizations, acknowledgements, and other documents that are required to be provided or made available to you during the course of our relationship with you. If you do not agree with this process, please let us know as described below.
