1 AN ORDINANCE relating to public transportation,
2 adopting a one-year increase to the limit of lost revenue
3 from waiving or discounting fares; amending Ordinance
4 12643, Section 18, as amended, and K.C.C. 4A.700.610
5 and Ordinance 12643, Section 18, as amended, and K.C.C.
6 4A.700.610 and establishing an effective date.

7 **STATEMENT OF FACTS:**

- 8 1. K.C.C. 4A.700.610 authorizes the director of the Metro transit
9 department to waive or discount fare or pass prices for the purpose of
10 attracting new ridership, relieving congestion, developing market
11 strategies, testing prices or experimental service, and implementing special
12 transit programs or promotions.
- 13 2. The annual loss in revenue of all such programs, promotions, and fare
14 discounts is limited to three hundred fifty thousand dollars.
- 15 3. Due to the extraordinary nature of the Major League Baseball All-Star
16 Game and its economic impact and tourism opportunities, the executive
17 announced free Metro transit department fares for the MLB All-Star Game
18 week in July 2023.

19 4. With the systemwide fare waivers during the MLB All-Star Game
20 week, the annual loss in revenue for the year 2023 is expected to exceed
21 the current limit.

22 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

23 SECTION 1. Findings:

24 A. The annual loss in revenue for the year 2023 from the systemwide fare waiver
25 during the MLB All-Star Game is estimated at four hundred seventy five thousand
26 dollars.

27 B. The Metro transit department also plans to continue prior years practice of
28 offering free fares on New Year's Eve, as well as issue limited free ride tickets and
29 promotions that meet the criteria of K.C.C. 4A.700.610.

30 C. The cumulative amount of fare waivers for the year 2023 is estimated to
31 exceed six hundred thousand dollars.

32 D. Due to the expected exceeding of the existing cap in 2023, retroactive
33 application of this ordinance is deemed prudent and appropriate.

34 SECTION 2. Section 3 of this ordinance is retroactive and applies to January 1,
35 2023, and thereafter.

36 SECTION 3. Ordinance 12643, Section 18, as amended, and K.C.C. 4A.700.610
37 are each amended to read as follows:

38 For the purpose of attracting new ridership, relieving congestion, developing
39 market strategies, testing prices or experimental service, and implementing other special
40 transit programs or promotions, the director may waive or discount the fare or pass prices
41 otherwise established in this chapter whenever the waiver or discount is not expected to

42 require the addition of regularly scheduled public transportation services and, in the
43 judgement of the director, the value of the program or promotion and the benefit to the
44 public exceeds the expected loss of revenue. The loss in revenue of all such programs,
45 promotions and fare discounts shall, in the aggregate be no greater than ~~((three))~~ seven
46 hundred ~~((fifty))~~ thousand dollars annually.

47 SECTION 4. Section 5 of this ordinance takes effect January 1, 2024.

48 SECTION 5. Ordinance 12643, Section 18, as amended, and K.C.C. 4A.700.610
49 are each amended to read as follows:

50 For the purpose of attracting new ridership, relieving congestion, developing
51 market strategies, testing prices or experimental service, and implementing other special
52 transit programs or promotions, the director may waive or discount the fare or pass prices
53 otherwise established in this chapter whenever the waiver or discount is not expected to
54 require the addition of regularly scheduled public transportation services and, in the
55 judgement of the director, the value of the program or promotion and the benefit to the
56 public exceeds the expected loss of revenue. The loss in revenue of all such programs,

57 promotions and fare discounts shall, in the aggregate be no greater than (~~seven~~) three
58 hundred fifty thousand dollars annually.





ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, King County-Department of 02 (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

Consequences of changing your mind

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. Further, you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.

All notices and disclosures will be sent to you electronically

Unless you tell us otherwise in accordance with the procedures described herein, we will provide electronically to you through the DocuSign system all required notices, disclosures, authorizations, acknowledgements, and other documents that are required to be provided or made available to you during the course of our relationship with you. To reduce the chance of you inadvertently not receiving any notice or disclosure, we prefer to provide all of the required notices and disclosures to you by the same method and to the same address that you have given us. Thus, you can receive all the disclosures and notices electronically or in paper format through the paper mail delivery system. If you do not agree with this process, please let us know as described below. Please also see the paragraph immediately above that describes the consequences of your electing not to receive delivery of the notices and disclosures electronically from us.

How to contact King County-Department of 02:

You may contact us to let us know of your changes as to how we may contact you electronically, to request paper copies of certain information from us, and to withdraw your prior consent to receive notices and disclosures electronically as follows:

To let us know of a change in your email address where we should send notices and disclosures electronically to you, you must send an email message to us at cipriano.dacanay@kingcounty.gov and in the body of such request you must state: your previous email address, your new email address. We do not require any other information from you to change your email address.

If you created a DocuSign account, you may update it with your new email address through your account preferences.

To request paper copies from King County-Department of 02

To request delivery from us of paper copies of the notices and disclosures previously provided by us to you electronically, you must send us an email to cipriano.dacanay@kingcounty.gov and in the body of such request you must state your email address, full name, mailing address, and telephone number. We will bill you for any fees at that time, if any.

To withdraw your consent with King County-Department of 02

To inform us that you no longer wish to receive future notices and disclosures in electronic format you may:

- i. decline to sign a document from within your signing session, and on the subsequent page, select the check-box indicating you wish to withdraw your consent, or you may;
- ii. send us an email to cipriano.dacanay@kingcounty.gov and in the body of such request you must state your email, full name, mailing address, and telephone number. We do not need any other information from you to withdraw consent.. The consequences of your withdrawing consent for online documents will be that transactions may take a longer time to process..

Required hardware and software

Acknowledging your access and consent to receive and sign documents electronically
