1 AN ORDINANCE relating to membership on the board of
2 health; and amending Ordinance 14989, Section 3, as
3 amended, and K.C.C. 2.35.021.

5 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

6 SECTION 1. Ordinance 14989, Section 3, as amended, and K.C.C. 2.35.021 are
7 each hereby amended to read as follows:

8 A. The King County board of health shall consist of the following members:

9 1. ~~((Six))~~ Three members of the metropolitan King County council to be
10 appointed by the chair of the council, provided that the chair shall consider appointing
11 members ~~((who represent districts in which a significant proportion of the population
12 resides in unincorporated areas))~~ such that county councilmember representation on the
13 board of health is geographically balanced across the county and includes representation of
14 the unincorporated area of the county on the board. Each county councilmember vote shall
15 be weighted as two votes;

16 2. Three elected officials of the city of Seattle to be appointed by the city;

17 3. Two elected officials from cities and towns of King County other than Seattle
18 to be appointed in a manner agreed to by and among the cities and towns representing a
19 majority of the populations of those cities and towns; and

20 4. Two health professionals who shall be appointed by a majority vote of the
21 other members of the board of health. One of the health professionals should have
22 knowledge of environmental health, including knowledge of septic systems and
23 groundwater quality. A third nonvoting member, who shall also be a health professional,
24 may be appointed by a majority vote of the other members of the board. The terms of
25 health professional members shall be established by the rules of the board.

26 B.1. Alternate members for each regular member may be appointed according to
27 the relevant procedures under subsection A.1, 2. or 3. of this section. During the
28 meeting, an alternate member shall indicate when he or she is serving in a regular
29 member's absence. When serving in a regular member's absence, an alternate member
30 shall act as a regular member.

31 2. If the board appoints a third nonvoting health professional member as

33 provided under subsection A.4. of this section, that member shall serve as an alternate
34 voting member in the absence of either of the two voting health professional members.




