NOTICE IS HEREBY GIVEN that a public hearing will be held before the Metropolitan King County Council, Room 1001, King County Courthouse, Seattle, Washington, on May 31, 2016 at 1:30 p.m. The purpose of this public hearing is to receive public testimony relating to Ordinance 18269, which adopted findings in support of and adopted for four months a moratorium on the acceptance of permits for and the establishment or location of marijuana producers, processors and retailers within unincorporated King County.

Background

Ordinance 18269 was adopted on April 25, 2016. A public hearing within sixty days of the enactment of a moratorium and the adoption of findings is required by RCW 36.70A.390. This hearing is only for public testimony on the moratorium.
