1 A MOTION appointing Matthew P. Carroll to a vacant
2 position on the Skykomish Town Council.

3 WHEREAS, the Skykomish Town Council is made up of five positions, with
4 members each serving four-year terms, and

5 WHEREAS, Position 3 on the Skykomish Town Council is currently vacant, and

6 WHEREAS, RCW 42.12.070 describes the process for filling a vacancy on local
7 governing bodies, and

8 WHEREAS, RCW 42.12.070 provides that, in case of a vacancy, remaining
9 members shall appoint a qualified person to fill the vacancy within ninety days of the
10 date that the vacancy occurs, and

11 WHEREAS, RCW 42.12.070 provides further that, if the local governing body
12 does not fill the vacancy within ninety days, its authority to fill the vacancy ceases, and
13 the county legislative authority is to appoint a qualified person to fill the vacancy, and

14 WHEREAS, due to unforeseen circumstances, the Skykomish Town Council has
15 not filled the town council vacancy within the specified ninety-day period, and

16 WHEREAS, the Skykomish Town Council has now identified, evaluated and
17 recommended Matthew P. Carroll for consideration by the King County council to fill the
18 Town Council vacancy, and

19 WHEREAS, Matthew P. Carroll currently serves as the Business Manager and

21 WHEREAS, Matthew P. Carroll's experience includes service with the Sky

22 Valley Youth Football Association, the Sky Valley Little League, the Monroe

23 Community Corrections Network, the Monroe School District Alternative High School

24 Advisory Committee and a number of Monroe School District bond committees, and

25 WHEREAS, Matthew P. Carroll has in the past held professional licenses related

26 to real estate and insurance services and served as a Washington State Certified Flagging


