1 **AMENDMENT TO PROPOSED ORDINANCE 2025-0250, VERSION 2**

2 On page 1, after line 17, insert:

3 "SECTION 1. Ordinance 19861, Section 96, as amended, is hereby
4 amended as follows:

5 CRISIS CARE CENTERS - From the crisis care centers levy fund there is
6 hereby disappropriated from:

7 Crisis care centers (\$1,000,000)

8 SECTION 2. The council directs that section 1 of this ordinance takes effect
9 before section 3 of this ordinance.

10 SECTION 3. Ordinance 19861, Section 96, as amended, is hereby
11 amended as follows:

12 CRISIS CARE CENTERS - From the crisis care centers levy fund there is hereby
13 appropriated to:

14 Crisis care centers \$1,000,000

15 ER1 EXPENDITURE RESTRICTION:

16 Of this appropriation, up to \$1,000,000 shall be expended or encumbered solely to
17 support and implement measures outlined in the specific requirements described in City
18 of Seattle Mayor Bruce Harrell's letter of support dated August 13, 2025, which is

19 attachment E to 2025-RPT0087, the Broadway Facility Notification Letter. The moneys
20 shall be authorized by King County and administered in conjunction with the city of
21 Seattle with concurrence from the six-person community advisory group appointed by the
22 city of Seattle described in item 4 in the letter of support. If the city has not appointed the
23 six-person community advisory group by February 4, 2026, the King County executive
24 may appoint individuals to the group in coordination with the King County council and
25 confirmed by council motion. Where applicable, the implementation of the specific
26 requirements outlined in the letter of support should be completed before the crisis care
27 center at the Broadway Facility opens. The executive should utilize responsible
28 contracting criteria described in Ordinance 19925 to invest in security, mobile crisis
29 responders, and community ambassadors for the area immediately surrounding the
30 Broadway Facility in advance of the opening of the central crisis response zone crisis
31 care center at the Broadway Facility.

32 The executive shall also coordinate with the selected operator to explore the
33 utilization of the undeveloped property on the south portion of the site, identified as
34 parcel number 1978201290, to facilitate outdoor access for patients."

36 Renumber the remaining sections consecutively and correct any internal references
37 accordingly.

39 **EFFECT prepared by S. Porter: Adds an ER of up to \$1M to be spent on**
40 **implementation of the specific requirements described in the Mayor's letter of support**
41 **dated August 13, 2025, the moneys shall be authorized by King County and**

42 *administered in concurrence of the six-person community advisory group appointed by*
43 *the city of Seattle described in item 4 in the letter of support. If Seattle does not appoint*
44 *the six-person advisory group by February 4, 2026, the King County Executive is*
45 *tasked with appointing the group. The amendment also requires the Executive to*
46 *explore the use of the undeveloped property on the south portion of the site, identified*
47 *as parcel number 1978201290, to facilitate outdoor access for patients.*
