King County is proposing this ordinance
to adopt the 2025 Annual Budget and
make appropriations for the operation
of county agencies and departments

ending December 31, 2025. The proposed budget for 2025 would be approximately \$10.18 billion. Of the total, \$1.27
billion would support general fund
agencies and \$6.98 billion would support
non-general fund agencies, and \$1.94
billion would support the capital
improvement program.

may offer amendments for consideration by the Council. Persons wishing to
testify on the Proposed Ordinance
should aftend the public hearing in
person or remotely on November 19,
2024, or provide testimony in writing
