1 AN ORDINANCE relating to the Ninth and Jefferson  
 2 building electrical system repair project; making a  
 3 supplemental appropriation not to exceed \$28,160,000 to  
 4 the Harborview building repair and replacement fund;  
 5 amending the Harborview 2017 Annual Budget Ordinance,  
 6 Ordinance 18397, Section 2, as amended, and Attachment  
 7 A, as amended, and declaring an emergency.

8 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

9 SECTION 1. This ordinance makes a supplemental appropriation not to exceed  
 10 \$28,160,000 to the Harborview building repair and replacement fund.

11 SECTION 2. Ordinance 18397, Section 2, as amended, is hereby amended by  
 12 adding thereto and inserting the following:

13 From the Harborview building repair and replacement fund there is hereby  
 14 appropriated and authorized to be disbursed the following amounts for the specific  
 15 project identified in this Attachment A to this ordinance.
