RE: Sewer Utility Franchise Update – Franchise No. 12379

Dear Sir or Madame:

In accordance with the "Application Procedures for Obtaining a Franchise for King County Rights-of-way," the District hereby submits this letter of application to update our existing franchise no. 12379. This update is intended to cover a recently annexed area at the Northeast extreme of the District's service area. The legal description and maps have been updated to include the newly annexed area and the District's future sewer service area in the same vicinity, as well as all unincorporated areas lying within the District's existing corporate boundaries.

The newly annexed area and the future service area at the Northeast extreme of the District's service area will be addressed in Amendment No. 2 to the District's 1999 Comprehensive Wastewater System Plan. This amendment is nearing completion and will be submitted for King County approval in the very near future. The amendment approval and franchise application will need to be processed concurrently to facilitate construction for a preliminary plat in the newly annexed area that is currently in process with King County.

The following items are also enclosed, as required:

1. King County Warrant No. 0688175, in the amount of \$1,400.00, made payable to the King County Treasury.
2. A metes and bounds legal description of the franchise area boundaries, labeled as Exhibit "A."
3. A map depicting the area covered by the legal description (8 copies).
4. A vicinity map showing the surrounding area (8 copies).

Please keep me informed of the status of this application and let me know if further information is needed.
