7 **BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:**

8 **NEW SECTION. SECTION 1.** There is hereby added to K.C.C. chapter 12.68 a
9 new section to read as follows:

10 **Ravensdale voting precinct.** The shooting of firearms is prohibited and a no
11 shooting area is established within the Ravensdale voting precinct, comprising the
12 following area:

13 All of the area bounded by the intersection of the north
14 margin of the Kent-Kangley Road (SR 516) and the
15 western margin of the Retreat-Kanaskat Road; thence,
16 southeasterly along the Retreat-Kanaskat Road to the
17 intersection of the southern margin of the Retreat-Kanaskat


18 Road and the southern margin of the Kanaskat-Kangley
19 Road; thence northeasterly to the intersection of the
20 northern margin of the Kanaskat-Kangley Road and the

21 eastern margin of the Kent-Kangley Road (SR 516);
22 thence, westerly along the Kent-Kangley Road (SR 516) to
23 the Point of Beginning.



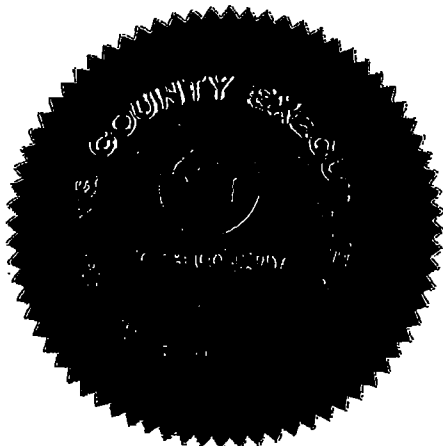

Dear Council Members:

I/we as elector-residents of Ravensdale hereby petition you to consider the creation of a no shooting area in King County defined as follows: All of Section 33, Township 22 North, Range 7 East, W.M., together with that portion of Section 34, Township 22 North, Range 7 East, W.M., lying south of the Kent Kangley Road (SR 516).

We also petition that this prohibition not apply to protection of persons and property. Petition signatures are enclosed.

There are four main reasons we feel the shooting of firearms should not be allowed in this area:

1. The noise impacting the surrounding area is disturbing, and the stray bullets projecting onto private property is unsafe.
2. With Sugarloaf Mountain purchased through the TDC program, there will be an increase in passive recreation within this entire area.
3. During hunting season, large numbers of hunters frequent the area. They put themselves in jeopardy, they also put children in jeopardy with the number of school bus stops along Kent Kangley Road and other surrounding streets.
4. There are safer alternatives for target shooters. Cascade Rifle and Pistol Club along with the King County Shooting Sports Park are located within 20 blocks. Special treatment is used to provide the safest shooting environment at these establishments.

Enclosed are a number of materials to help you decide on this matter. There is a detailed map of the area. The area under consideration is shaded. Also, we have included a computer generated aerial photograph that puts the area into better perspective. The area outlined in the photo is the area under consideration. The circled area is a small gravel area where we would estimate 250-750 rounds of gunfire are shot in an average week. The area just to the west of this gravel space was recently clear cut for timber. Now there are very few trees to absorb stray bullets shot by target shooters and hunters. This poses more danger to bike riders, hikers, and horseback riders who already frequent the area. Finally, two articles have been retrieved which depict a couple of most recent events that happened in the immediate area.
