15 this reference made a part hereof.


16 SECTION 2. Terms and conditions of said agreement shall be effective from



**AGREEMENT BETWEEN
KING COUNTY AND
WASHINGTON STATE COUNCIL OF COUNTY AND CITY EMPLOYEES
LOCAL NO. 21-HEALTH DEPARTMENT, AFL-CIO**

PREAMBLE

These articles constitute an Agreement, the terms of which have been negotiated in good faith by representatives of King County (hereinafter referred to as the County or the Health Department) and Washington State Council or County and City Employees, Local 21-HEALTH DEPARTMENT, AFL-CIO (hereinafter referred to as the Union).

The intent and purpose of this Agreement is to promote the continued improvement of the relationship between the County and the employees represented by the Union by providing a uniform basis for implementing the right of public employees to join organizations of their own choosing and to be represented by such organizations in matters concerning their relations with the County, and to set forth the wages, hours, and other conditions of bargaining unit employees, provided the County has such authority to act on such matters. This Agreement shall be subject to approval by ordinance by the County Council of King County, Washington.

1 **ARTICLE 1: NONDISCRIMINATION**

2 **Section 1.** The County and the Union agree all terms and conditions of employment included
3 in this Agreement shall be administered and applied in a manner that is nondiscriminatory under
4 federal or state law, or County Ordinance which prohibit discrimination on the basis of one or all of
5 the following: race, color, age, sex, marital status, sexual orientation, political ideology, creed,
6 religion, ancestry, or national origin, or disability. Disputes arising under this article shall not be
7 subject to arbitration procedures provided in Article 5 of this Agreement.

8 **Section 2.** Whenever words denoting the feminine or masculine gender are used in this
9 Agreement, they are intended to apply to either gender.

1 **ARTICLE 2: RECOGNITION AND BARGAINING UNIT**

2 **Section 1.** The County hereby recognizes the Union as the exclusive collective bargaining
3 representative of Health Department employees whose job classifications are listed in the attached
4 Addendum. This shall include all such employees not otherwise excluded in the following sections
5 of this Article.

1 **ARTICLE 3: MANAGEMENT RIGHTS**

2 **Section 1.** The right to hire, appoint, promote, discipline for just cause, improve efficiency,
3 and determine work schedules and the location of Department facilities are examples of management
4 prerogatives. It is understood that the Health Department retains its right to manage and operate its
5 divisions except as may be limited by an express provision of this Agreement. This Agreement shall
6 not limit the right of the County to contract for services of any and all types, except that the County
7 agrees not to contract out for services that would result in the elimination of bargaining unit positions.

8 **Section 2.** Delivery of health services in the most efficient, effective, and courteous manner is
9 of paramount importance to the County and, as such, maximized productivity is recognized to be an
10 obligation of the parties to this Agreement. In order to achieve this goal, the parties hereby recognize
11 the County's and the Department's right to determine the methods, processes, and means of providing
12 health services, the right to increase or diminish operations, in whole or in part, the right to increase,
13 diminish or change equipment, including the introduction of any and all new, improved, or automated
14 methods or equipment, and the assignment of employees to specific jobs within the bargaining unit.

15 **Section 3.** The Union recognizes the County's and the Department's right to establish and/or
16 revise the Department's performance evaluation system. Such system may be used to determine
17 acceptable performance levels, prepare work schedules, and to measure the performance of each
18 employee or group of employees.

1 **ARTICLE 4: UNION MEMBERSHIP AND DUES**

2 **Section 1.** It shall be a condition of employment that all employees covered by this
3 Agreement who are members of the Union shall remain members in good standing, or pay an agency
4 fee to the Union for their representation to the extent permitted by law. All employees hired in
5 positions covered by this Agreement on or after its effective date shall, on the thirtieth (30th) day
6 following such employment, become and remain members in good standing in the Union, or pay an
7 agency fee to the Union for their representation to the extent permitted by law. Employees who
8 qualify for exemption from this requirement based upon a good faith religious belief, or bona fide
9 religious tenets or teachings of a church or religious body of which the employee is a member, shall
10 contribute an amount equivalent to regular Union dues or agency fee to a nonreligious charity
11 mutually agreed upon by the employee and the Union.

12 **Section 2.** The County agrees to deduct from the paycheck of each employee, who has so
13 authorized it, regular monthly dues (or agency fees) uniformly required of members of the Union.
14 The amounts deducted shall be transmitted monthly to the Union on behalf of the employees
15 involved. Authorization by the employee shall be on a form approved by the parties hereto and may
16 be revoked by the employee upon request. The performance of this function is recognized as a
17 service to the Union by the County.

18 **Section 3.** The Union agrees to indemnify and save harmless the County from any and all
19 liability resulting from the dues check-off system, the Union security obligation, and the religious
20 exemption requirements, except as delineated in Section 4 below.

21 **Section 4.** Failure by an employee to abide by the afore referenced provisions shall constitute
22 cause for discharge of such employee; provided, however, it shall be the responsibility of the Union
23 to notify the Health Department Director, with a copy to the Department of Executive Services,
24 Human Resources Division Director, in writing when it is seeking discharge of an employee for
25 noncompliance with Section 4 of this Article. When an employee fails to fulfill the union security
26 obligations set forth within this Article, the Union shall forward a "Request for Discharge Letter" to
27 the Health Department Director (with copies to the affected employee and the Human Resources
28 Division Director of the Department of Executive Services). Accompanying the discharge letter shall

1 be a copy of the letter to the employee from the Union explaining the employee's obligation under
2 Article 4, Section 4.

3 The contents of the "Request for Discharge Letter" shall specifically request the discharge of
4 the employee for failure to abide by Article 4, Section 4, but provide the employee and the County
5 with thirty (30) calendar days' written notification of the Union's intent to initiate discharge action,
6 during which time the employee may make restitution in the amount which is overdue. Upon receipt
7 of the Union's request, the Health Department Director shall give notice in writing to the employee,
8 with a copy to the Union and the County that the employee faces discharge upon the request of the
9 Union at the end of the thirty (30)-calendar day period noted in the Union's "Request for Discharge
10 Letter" and that the employee has an opportunity before the end of said thirty (30)-calendar day
11 period to present to the Health Department Director any information relevant to why the Health
12 Department should not act upon the Union's written request for the employee's discharge. In the
13 event the employee has not yet fulfilled the obligation set forth within Section 4 of this Article within
14 the thirty (30)-calendar day period noted in the "Request for Discharge Letter," the Union shall
15 thereafter reaffirm in writing to the Health Department Director with copies to the affected employee
16 and the County, its original written request for discharge of such employee. Unless sufficient legal
17 explanation or reason is presented by the employee why discharge is not appropriate or unless the
18 Union rescinds its request for the discharge the County shall, as soon as possible thereafter, effectuate
19 the discharge of such employee. If the employee has fulfilled the union security obligation within the
20 thirty (30)-calendar day period, the Union shall so notify the Health Department Director in writing,
21 with a copy to the County and the affected employee. If the Union has reaffirmed its request for
22 discharge, the Health Department Director shall notify the Union in writing, with a copy to the
23 County and the affected employee, that the Department effectuated, or that the Health Department has
24 not discharged the employee, setting forth the reasons why it has not done so.

1 **ARTICLE 5: GRIEVANCE PROCEDURE**

2 **Section 1.** The Department recognizes the importance and desirability of settling grievances
3 promptly and fairly in the interest of continued good employee relations and morale. To accomplish
4 this, every effort will be made to settle grievances at the lowest possible level of supervision with the
5 understanding that grievances will be filed at the step at which there is authority to adjudicate,
6 provided the immediate supervisor is notified.

7 **Section 2.** A contract grievance in the interest of a majority of the employees in the
8 bargaining unit shall be reduced to writing by the Union and may be introduced at Step 2 of the
9 grievance procedure and processed within the time limits set forth therein.

10 **Section 3.** Grievances processed through Step 3 of the grievance procedure are to be heard on
11 Department time and no employee shall receive compensation beyond normal working hours while
12 attending grievance meetings unless stipulated otherwise by the parties.

13 **Section 4.** Employees will be unimpeded and free from restraint, interference, coercion,
14 discrimination, or reprisal in seeking adjudication of their grievance.

15 Probationary employees shall not have the right to pursue grievances over dismissal but shall
16 be able to pursue grievances as otherwise provided. Regular employees reverted during probation
17 shall not have the right to pursue grievances over reversion but shall be able to pursue grievances as
18 otherwise provided.

19 **Section 5.** Definition. Any dispute arising during the term of this Agreement between the
20 County and the Union or between the County and any employee covered by this Agreement
21 concerning the interpretation, application, claim of breach or violation of the express terms of this
22 Agreement shall be deemed a grievance.

23 Working days referred to in the grievance procedure shall be defined as Monday through
24 Friday excluding observed holidays.

25 Any time limits agreed to in the grievance procedure may be extended for stated periods of
26 time by the appropriate parties by mutual agreement in writing. Failure by an employee or the Union
27 to comply with any time limitation of the procedure of this Article shall constitute withdrawal of the
28 grievance.

1 **Section 6.** Grievance procedure.

2 **Step 1:** A grievance shall be presented in writing by the aggrieved employee and/or
3 Union representative to the employee's immediate supervisor within ten (10) working days of the
4 alleged contract violation or knowledge of the violation. The grievance notice shall be dated and
5 shall include the date of the incident, the issue(s), and the due date (ten (10) working days) for the
6 immediate supervisor's response. After consulting with the District Administrator/Manager, the
7 immediate supervisor shall attempt to resolve the matter and notify the employee or Union
8 representative in writing within ten (10) working days of receipt of the grievance.

9 If the employee and/or Union representative do not receive a response at Step 1 within the
10 time frames listed above, the grievance may be elevated to Step 2. If the grievance is not pursued to
11 the next step within ten (10) working days following receipt of the written Step 1 response from the
12 immediate supervisor, it shall be presumed resolved.

13 **Step 2:** If the grievance is not resolved at Step 1 or is filed initially at Step 2, the
14 employee or Union representative shall present the grievance in writing, specifying the section(s) of
15 the contract allegedly violated and the remedy sought. The grievance shall then be presented to the
16 Division Manager for investigation, discussion and written reply. The Division Manager, after
17 consulting with the Department Director, shall meet with the Union and the grievant within ten
18 working days. The Division Manager then will make a written decision and present it to the
19 aggrieved employee and/or Union representative with a copy mailed to the Union within ten (10)
20 working days of the Step 2 grievance hearing. If the employee and/or Union representative do not
21 receive a response at Step 2 within the time frames listed above, the grievance may be elevated to
22 Step 3. If the grievance is not pursued to the next higher level within ten (10) working days from the
23 Union's receipt of the Division Manager's written response, it shall be presumed resolved.

24 **Step 3:** If the decision of the Division Manager has not resolved the grievance, the
25 grievance may be presented to the King County Human Resources Division Director, Department of
26 Executive Services, with a copy to the Labor Relations Manager and the Health Department
27 Personnel Office. The Director of the Human Resources Division, Department of Executive Services
28 or designee shall hear the grievance and respond in writing to the employee and Union representative

1 within ten (10) working days following the presentation of the grievance. The meeting to hear the
2 grievance will be scheduled as soon as practical, but not less than thirty (30) days after receipt of the
3 Step 3 grievance by Human Resources Division, Department of Executive Services.

4 **Step 4:** If the Step 3 decision does not resolve the grievance to the satisfaction of the
5 Union or the County, either the Union or the County may request arbitration within thirty (30)
6 calendar days of the Union's receipt of the Step 3 decision. Grievances relating to written or oral
7 reprimands shall not be appealed to arbitration. The request for arbitration must specify:

- 8 a. Section(s) of the Agreement allegedly violated
- 9 b. Nature of the alleged violation
- 10 c. Remedy sought

11 The Union and the County shall then select a third disinterested party to serve as arbitrator. In
12 the event that the parties are unable to agree upon an arbitrator, then the arbitrator shall be selected
13 from a panel of seven arbitrators furnished by the Federal Mediation and Conciliation Service
14 (FMCS). The arbitrator will be selected from the list by the Department representative and the Union
15 alternately striking a name from the list until only one remains.

16 In connection with any arbitration proceeding held pursuant to the Agreement, it is understood
17 as follows:

18 1. The arbitrator shall have no power to render a decision that will add to, subtract
19 from, alter, change, or modify the terms of this Agreement, and all other matters shall be excluded
20 from arbitration.

21 2. The decision of the arbitrator shall be final, conclusive and binding upon the
22 County, the Department, the Union, and the employee involved.

23 3. The cost of the arbitrator shall be borne equally by the Department and the Union.
24 Each party shall bear the cost of presenting its own case including the cost of any witnesses appearing
25 on that party's behalf. Each party shall bear the cost of its own attorney fees regardless of the
26 outcome of the hearing.

27 4. The arbitrator's decision shall be made in writing and shall be issued to the parties
28 within thirty (30) calendar days after the case is submitted to the arbitrator.

1 5. Any arbitrator selected under Step 4 of this Article shall function pursuant to the
2 voluntary labor arbitration regulations of the American Arbitration Association unless stipulated
3 otherwise in writing by the parties to this Agreement.

4 There shall be no strike, cessation of work or lockout during hearings or arbitrations.

5 Arbitration awards or grievance settlements shall not be made retroactive beyond the date of
6 the occurrence or nonoccurrence upon which the grievance is based, that date being fourteen (14)
7 calendar days or less prior to the initial filing of the grievance.

8 Mediation: Prior to submitting a dispute to arbitration, the parties may agree to select a
9 neutral third party to serve as mediator. If mediation is not successful, arbitration may be requested
10 as provided above, within thirty (30) days after the mediator or one of the parties declares impasse.

11 Section 7. An employee covered by this Agreement must, upon initiating objections relating
12 to disciplinary action, use either the contractual grievance procedure contained herein or disciplinary
13 appeals under the King County Personnel Guidelines.

14 Under no circumstance may an employee use both the contractual grievance procedure and a
15 personnel system appeal procedure relative to the same action. If there are dual filings with the
16 grievance procedure and a personnel system appeal procedure, the County will send notice of such
17 filings by certified mail to the employee(s) and the Union. The Union will notify the County Labor
18 Relations Manager by certified mail within fifteen (15) calendar days from the date of receipt of the
19 notice if it will use the contractual grievance procedure. If no such notice is received by the County
20 Labor Relations Manager, the contractual grievance action shall be deemed to be withdrawn.

1 **ARTICLE 6: WORK STOPPAGES**

2 The County, Department, and Union agree that the public interest requires the efficient and
3 uninterrupted performance of all health services and, to this end, pledge their best efforts to avoid or
4 eliminate any conduct contrary to this objective. During the life of the Agreement, the Union shall
5 not cause any work stoppage, strike, slowdown, or other interference with County and/or Department
6 functions by employees under this Agreement. The Union agrees to take appropriate steps to end
7 such interference if it occurs. Employees shall not cause or engage in any work stoppage, strike,
8 slowdown, or other interference with County and/or Department functions for the term of this
9 Agreement. Employees covered by this Agreement who engage in any of the foregoing actions shall
10 be subject to such disciplinary actions as may be determined by the County and/or Department,
11 including but not limited to, the recovery of any financial losses suffered by the County and/or
12 Department.

1 **ARTICLE 7: CLASSIFICATIONS AND RATES OF PAY**

2 **Section 1.**

3 A. Effective January 1, 2006, the base wage rates set forth in Addendum A shall be
4 increased by 90% of the increase in the U.S. Cities CPI-W from September 2004 to September 2005.
5 The salary increase will be no less than 2% nor greater than 6%, rounded to the nearest one-hundredth
6 of a percent.

7 B. Effective January 1, 2007, the base wage rates set forth in Addendum A shall be
8 increased by 90% of the increase in the U.S. Cities CPI-W from September 2005 to September 2006.
9 The salary increase will be no less than 2% nor greater than 6%, rounded to the nearest one-hundredth
10 of a percent.

11 C. Effective January 1, 2008, the base wage rates set forth in Addendum A shall be
12 increased by 90% of the increase in the U.S. Cities CPI-W from September 2006 to September 2007.
13 The salary increase will be no less than 2% nor greater than 6%, rounded to the nearest one-hundredth
14 of a percent.

15 D. Bi-Weekly Payroll. Upon adoption by the King County Council the County may
16 use a bi-weekly payroll.

17 **Section 2.** When a position is reclassified to a new or different class having a different salary
18 range, the employee occupying the position immediately prior to and at the time of reclassification
19 shall receive the salary rate which shall be determined in the same manner as for a promotion;
20 provided that, if the employee's salary prior to reclassification is higher than the maximum salary of
21 the range for such new or different class, he shall continue to receive such higher salary as an
22 "incumbent" for so long as he remains in such position or until the regular salary for the classification
23 exceeds the "incumbent" rate of pay.

24 **Section 3.**

25 A. Pay Ranges: Pay ranges and pay range assignments shall be as set forth in
26 Addendum A.

27 B. Step Increases:

28 1. Salary increases upon completion of Probation. Prospective upon

1 implementation of this agreement, employees may receive within-range increases from one step to the
2 next higher step upon satisfactory completion of the probationary period. All probationary-period pay
3 increases must be supported by documented performance appraisal. Probationary-period pay
4 increases exceeding Step 5 must have prior written approvals by the Department Director and Human
5 Resources Director.

6 2. Regular Step Increases. Step increases shall be granted on January 1st of
7 each year, and shall be based upon satisfactory performance.

1 **ARTICLE 8: ANNUAL VACATIONS**

2 **Section 1.** Full-time benefit eligible employees, shall receive vacation benefits as indicated in
3 the following table:

22 Benefit eligible employees shall expend accrued hours of vacation on an hour-for-hour basis.
23 That is, an employee working a 10-hour day shall use 10 hours for each day of vacation.

24 **Section 2.** Benefit eligible employees shall accrue vacation benefits on an hourly basis.

25 **Section 3.** Vacation benefits for benefit eligible part-time employees will be established
26 based upon the number of regular compensated hours.

27 **Section 4.** No person shall be permitted to work for compensation for the County in any
28 capacity during the time when vacation benefits are being drawn.

1 **Section 5.** Vacation may be used in one-half hour increments at the discretion of the
2 department director or his appointed designee.

3 **Section 6.** Benefit eligible employees who leave King County employment for any reason
4 will be paid for their unused vacation up to the maximum specified herein. Employees shall forfeit
5 the excess accrual prior to December 31st of each year.

6 **Section 7.** “Short term” Temporary employees will not be granted vacation benefits.

7 **Section 8.** In cases of separation by death, payment of unused vacation benefits shall be made
8 to the employee’s estate, or in applicable cases, as provided by R.C.W., Title 11.

9 **Section 9.** Employees eligible for vacation leave may accrue up to sixty days vacation leave,
10 prorated to reflect their normally scheduled workweek. Such employees shall use vacation leave
11 beyond the maximum accrual amount prior to December 31 of each year. Failure to use vacation
12 leave beyond the maximum accrual amount will result in forfeiture of the vacation leave beyond the
13 maximum amount unless the appointing authority has approved a carryover of such vacation leave
14 because of cyclical workloads, work assignments or other reasons as may be in the best interests of
15 the County.

16 **Section 10.** Shared leave. Benefit eligible employees may share leave with other County
17 employees in accordance with King County Ordinance on this subject. Donation of vacation leave
18 hours and donation of sick leave hours.

19 A. Vacation leave hours.

20 1. Any benefit eligible employee who is employed at least half-time and
21 receives vacation and sick leave, may donate a portion of his or her accrued vacation leave to a full-
22 time employee or part-time employee who is employed at least half-time and receives vacation and
23 sick leave. Such donation will occur upon written request to and approval of the donating and
24 receiving employees’ department director(s), except that requests for vacation donation made for the
25 purposes of supplementing the sick leave benefits of the receiving employee shall not be denied
26 unless approval would result in a departmental hardship for the receiving department.

27 2. The number of hours donated shall not exceed the donor’s accrued vacation
28 credits as of the date of the request. No donation of vacation hours shall be permitted where it would

1 cause the employee receiving the transfer to exceed his or her maximum vacation accrual.

2 3. Donated vacation leave hours must be used within ninety (90) calendar days
3 following the date of donation. Donated hours not used within ninety (90) days, or due to the death of
4 the receiving employee, shall revert to the donor. Donated vacation leave hours shall be excluded
5 from vacation leave payoff provisions contained in this chapter. For purposes of this section, the first
6 hours used by an employee shall be accrued vacation leave hours.

7 **B. Sick leave hours.**

8 1. Any benefit eligible full-time employee, or benefit eligible part-time
9 employee who is employed at least half-time and receives vacation and sick leave, may donate a
10 portion of his or her accrued sick leave to a full-time employee or part-time employee who is
11 employed at least half-time and receives vacation and sick leave, upon written notice to the donating
12 and receiving employee's department director(s).

13 2. No donation shall be permitted unless the donating employee's sick leave
14 accrual balance immediately subsequent to the donation is one hundred (100) hours or more. No
15 employee may donate more than twenty-five (25) hours of his or her accrued sick leave in a calendar
16 year.

17 3. Donated sick leave hours must be used within ninety (90) calendar days.
18 Donated hours not used within ninety (90) days or due to the death of the receiving employee shall
19 revert to the donor. Donated sick leave hours shall be excluded from the sick leave payoff provisions
20 contained in this Agreement, and sick leave restoration provisions contained in this Agreement. For
21 purposes of this section, the first hours used by an employee shall be accrued sick leave hours.

22 **C. All donations of vacation and sick leave made under this chapter are strictly**
23 **voluntary. Employees are prohibited from soliciting, offering or receiving monetary or any other**
24 **compensation or benefits in exchange for donating vacation or sick leave hours.**

25 **D. All vacation and sick leave hours donated shall be converted to a dollar value**
26 **based on the donor's straight time hourly rate at the time of donation. Such dollar value will then be**
27 **divided by the receiving employee's hourly rate to determine the actual number of hours received.**
28 **Unused donated vacation and sick leave shall be reconverted based on the donor's straight time**

1 hourly rate at the time of reconversion.

2 **Section 11.** All other leaves shall be as provided by King County Ordinance.

1 **ARTICLE 9: HOLIDAYS**

2 **Section 1.** The following day or days in lieu thereof shall be recognized as holidays without
3 salary deduction for benefit eligible employees:

4	New Year's Day	January 1
5	Martin Luther King, Jr.'s Birthday	Third Monday in January
6	President's Day	Third Monday in February
7	Memorial Day	Last Monday in May
8	Independence Day	July 4
9	Labor Day	First Monday in September
10	Veteran's Day	November 11
11	Thanksgiving Day	Fourth Thursday in November
12	Day after Thanksgiving Day	Day immediately following
13	Christmas Day	December 25
14	2 Personal Holidays	

15
16 Whenever any holiday specified above falls upon a Sunday, the following Monday shall be
17 considered a holiday. Whenever any holiday specified above falls upon a Saturday, the preceding
18 Friday shall be considered the holiday; provided, however, paid holidays falling on Saturday or
19 Sunday, shall be recognized and paid pursuant to Section 4 on those actual days (Saturday or Sunday)
20 for employees who are regularly scheduled to work those days. Payment pursuant to Section 4 shall
21 be made only once per affected employee for any one holiday.

22 **Section 2.** Personal Holidays

23 a. Benefit eligible employees shall be granted two personal holidays to be
24 administered through the vacation plan. One day shall be granted the first of October and one day
25 shall be granted the first of November.

26 b. Personal holidays shall be administered through the vacation plan and can be used
27 in the same manner as any earned vacation day.

28 **Section 3.** Holidays paid for but not worked shall be recognized as time worked for the

1 purpose of determining weekly overtime.

2 **Section 4.** Benefit eligible employees who work on a holiday shall be paid for the holiday at
3 their regular straight-time hour rate of pay and, in addition, shall be paid at the rate of one and one-
4 half (1-1/2) times their regular straight-time hourly rate of pay for hours worked.

5 **Section 5.** To qualify for holiday pay, benefit eligible employees covered by this Agreement
6 must have been on the payroll prior to the holiday and on pay status the normal workday before and
7 the normal workday after the holiday; provided, that employees returning from nonpay leave starting
8 work the day after a holiday shall not be entitled to pay for the holiday preceding their first day of
9 work.

10 **Section 6.** A benefit eligible part-time employee shall receive prorated paid holiday time off
11 (or paid time off in lieu thereof) based upon straight time hours compensated during the pay period
12 immediately prior to the pay period in which the holiday falls.

13 **Section 7.** Holiday Pay for Employees on Alternative Work Schedules.

14 Benefit eligible employees scheduled to work an alternative work week, such as four ten-hour
15 days, shall be granted no more than ninety-six (96) holiday hours (to include Personal Holidays) per
16 year. Benefit eligible employees working alternative work weeks whose departments close on a
17 designated holiday will be allowed to use accrued but unused time off (vacation or compensatory
18 time) for time off that exceeds their standard work day or take leave without pay, or by mutual
19 agreement with the supervisor, the employee shall be allowed to work to make up the hours during
20 that same work week. In no event will the rescheduling of hours in this manner be allowed if the
21 resulting hours of work will result in overtime pay. When a holiday falls on an employee's regularly
22 scheduled day off, the employee will have the option of receiving the holiday pay at the straight time
23 rate in the same pay period or of scheduling an alternate paid day off within thirty (30) days of the
24 actual holiday.

25 **Section 8.** Holiday Pay for Employees Working in a 24 hour facility.

26 In each instance noted below, holiday pay for work on a holiday is included in the bi-monthly
27 pay schedule. In addition to this holiday pay for work on a holiday, employees working in a 24 hour
28 facility will have the following options:

1 **A. Scheduled / Working:** A benefit eligible employee has the option of payment for
2 actual hours worked at one and one half (1-1/2) times their regular straight time hourly rate or
3 compensatory time for actual hours worked times the rate of one and one half(1-1/2).

4 **B. Scheduled / Not Working:** If a benefit eligible employee is normally scheduled to
5 work an eight (8) hour day, then no action is necessary other than submitting a leave request. If an
6 employee is scheduled for more than eight (8) hours, a vacation request must be submitted for time
7 off beyond eight (8) hours. For example, if scheduled to work ten (10) hours, then the employee must
8 submit a request for two (2) hours using vacation, compensatory time, or time without pay.

9 **C. Not Scheduled / Working:** A benefit eligible employee must be compensated for
10 the holiday falling on a regularly scheduled day off. The employee must choose between eight (8)
11 hours of Holiday pay or eight (8) hours of compensatory time earned at their regular straight rate.
12 Employees will not be required to take compensatory time within thirty (30) days. For time spent
13 working on a holiday that falls on a regularly scheduled day off payment for actual hours worked at
14 1-1/2 times the hourly rate or compensatory time for actual hours worked at 1-1/2 times the hours
15 worked.

16 **D. Not Scheduled / Not Working:** A benefit eligible employee must be
17 compensated for the holiday falling on a regularly scheduled day off. This employee must choose
18 between eight (8) hours of holiday pay or eight (8) hours of compensatory time earned at a straight
19 rate. Employees will not be required to take compensatory time within thirty days.

1 **ARTICLE 10: SICK LEAVE, INDUSTRIAL INJURY AND BEREAVEMENT LEAVE**

2 Sick leave and time off for family medical reasons shall be administered in accordance with
3 the provision of King County Substitute Ordinance No. 13377, including but not limited to:

- 4 A. eligibility for family and medical leave;
- 5 B. administration of family and medical leaves;
- 6 C. verifications for determining eligibility for family and medical leave;
- 7 D. use of accrued leave to supplement workers compensation payments;
- 8 E. medical benefit coverage during family and medical leave; and
- 9 F. return to work rights upon completion of leave.

10 The sections below are intended to describe, but not modify or expand, the provisions of the
11 ordinance. If, during the term of this Agreement, the County Council adopts amendments to the
12 Family and Medical Leave provisions which affect eligibility or benefit levels, the County agrees to
13 negotiate the effect of such amendments if requested by the Union.

14 **Section 1.** Every benefit eligible employee shall accrue sick leave benefits at the rate of
15 0.04616 hours for each hour in a pay status exclusive of overtime up to a maximum of 8 hours per
16 month, except that sick leave shall not begin to accrue until the first of the month following the
17 month in which the employee commenced service.

18 **Section 2.** Sick leave may be used in one-half hour increments at the discretion of the
19 division manager.

20 **Section 3.** There shall be no limit to the hours of sick leave benefits accrued by an employee.

21 **Section 4.** Accrued sick leave may be used for the following reasons:

22 1. The benefit eligible employee's bona fide illness; provided, that an employee who
23 suffers an occupational illness may not simultaneously collect sick leave and worker's compensation
24 payments in a total amount greater than the net regular pay of the employee.

25 2. The benefit eligible employee's incapacitating injury, provided that:
26 a. A benefit eligible employee injured on the job may not simultaneously
27 collect sick leave and worker's compensation payments in a total amount greater than the net regular
28 pay of the employee;

1 b. A benefit eligible employee may not collect sick leave for physical
2 incapacity due to any injury or occupational illness which is directly traceable to employment other
3 than with the County.

4 3. Exposure to contagious diseases and resulting quarantine.

5 4. A benefit eligible female employee's temporary disability caused by or contributed
6 to by pregnancy and childbirth.

7 5. The benefit eligible employee's medical or dental appointments, provided that the
8 employee's appointing authority has approved the use of sick leave for such appointments.

9 6. To care for the benefit eligible employee's child or the child of an employee's
10 domestic partner if the following conditions are met:

11 a. The child is under the age of eighteen;

12 b. The benefit eligible employee is the natural parent, stepparent, adoptive
13 parent, legal guardian or other person having legal custody and control of the child;

14 c. The benefit eligible employee's child or the child of an employee's
15 domestic partner has a health condition requiring the employee's personal supervision during the
16 hours of his/her absence from work;

17 d. The employee actually attends to the child during the absence from work.

18 **Section 5.** Illness within the employee's immediate family which requires the attendance of
19 the employee or where the employee's presence on the job could jeopardize the health of fellow
20 employees. Under these conditions, the employee may use accrued sick leave the same as if the
21 employee was personally under a medical disability. The supervisor may require a doctor's certificate
22 showing the requirement that the employee be in attendance.

23 **Section 6.** In each case of absence due to illness or injury, it shall be the responsibility of the
24 employee to notify the employee's supervisor of the absence and the anticipated duration of the
25 absence. Except in emergency situations, failure to notify the supervisor of an absence prior to the
26 commencement of the employee's shift shall be grounds for disciplinary action.

27 **Section 7.** Up to one day of sick leave may be used by an employee for the purpose of being
28 present at the birth of his/her child.

1 **Section 8.** An employee who has exhausted all of his/her sick leave may use accrued vacation
2 leave as sick leave before going on leave of absence without pay, if approved by the department.

3 **Section 9.** Department management is responsible for the proper administration of the sick
4 leave benefit.

5 **Section 10.** Separation from King County employment, except by retirement, death or reason
6 of temporary lay-off due to lack of work or funds, shall cancel all sick leave currently accrued to the
7 employee. Should the employee resign in good standing, or separate for non-disciplinary medical
8 reasons, and return to the County within two years, accrued sick leave shall be restored.

9 **Section 11.** Sick leave because of an employee's physical incapacity will not be approved
10 when the injury is directly traceable to simultaneous employment other than with King County.

11 **Section 12.** King County will reimburse those employees who have at least five (5) years
12 service and retire as a result of length of service or who terminate by death, thirty-five percent (35%)
13 of their unused, accumulated sick leave. All payments shall be made in cash, based on the
14 employee's base rate, and there shall be no deferred sick leave reimbursement.

15 **Section 13.** Employees injured on the job cannot simultaneously collect sick leave and
16 workers compensation payments greater than net pay of the employee. Administrative rules will be
17 established to allow for payments equal to net regular pay of employees qualifying under workers
18 compensation.

19 **Section 14.** Employees will be allowed to use paid sick leave for volunteering at their
20 children's school as provided for by King County Ordinance.

21 **Section 15.** Wellness Incentive.

22 Regular and term-limited temporary employees who have been employed for a full calendar
23 year and during a calendar year use less than thirty-three (33) hours of sick leave, may convert eight
24 (8) hours of unused, accrued sick leave to a personal vacation day to be used in the next calendar
25 year. This incentive shall be prorated for part-time employees.

26 **INDUSTRIAL INJURY**

27 **Section 16.** All employees shall be covered by the County's Industrial Insurance Program
28 except that any claim filed under the City's Industrial Insurance Program prior to the date of transfer

1 Date, whether still open or reopened after that date, shall continue to be administered by the City of
2 Seattle under its program.

3 **Section 17.** Appeals of any denials under this Article shall be made through the Department
4 of Labor and Industries as prescribed in Title 51 RCW.

5 **BEREAVEMENT/FUNERAL LEAVE**

6 **Section 18.** Annual Entitlement. All benefit eligible employees shall be entitled to three
7 working days of bereavement leave per each occurrence of death of members of their immediate
8 family. For purposes of this section, "immediate family" shall mean persons related by blood or
9 marriage or legal adoption as follows: mother, mother-in-law, father, father-in-law, legal spouse, son,
10 daughter, grandparent, grandchild, brother or sister of the employee or, in lieu of the legal spouse, a
11 significant other person or domestic partner living in the employee's household.

12 **Section 19.** Use of Sick Leave for Bereavement Purposes. Full time regular employees who
13 have exhausted their bereavement leave shall be entitled to use sick leave in the amount of three days
14 for each instance when death exists to a member of the employee's immediate family. One day of
15 sick leave per year may be used for the attendance of a funeral of other than a member of the
16 employee's immediate family.

17 **Section 20.** In cases of family death where no sick leave benefit is authorized or exists, an
18 employee may be granted leave without pay.

19 **Section 21.** Holidays and Regular Days Off. In the application of Bereavement Leave,
20 holidays or regular days off falling within the prescribed period of absence shall not be charged.

21 **Section 22.** Pro-Rata Benefit for Part-time Regular Employees. Part-time regular employees
22 shall be entitled to bereavement leave prorated to their normal work schedule.

1 **ARTICLE 11: ORGAN DONORS LEAVE**

2 **Section 1.** Leave for Organ Donors. The Department shall allow employees eligible for
3 family leave, sick leave, vacation leave or leave of absence without pay who are voluntarily
4 participating as donors in life-giving or life-saving procedures such as, but not limited to, bone
5 marrow transplants, kidney transplants, or blood transfusions to take five (5) days paid leave without
6 having such leave charged to family leave, sick leave, vacation leave or leave of absence without pay;
7 provided that the employee shall:

8 1. Give the Department reasonable advance notice of the need to take time off from
9 work for the donation of bone marrow, a kidney, or other organs or tissue, if there is a reasonable
10 expectation that the employee's failure to donate may result in illness, injury, pain or the eventual
11 death of the identified recipient.

12 2. Provide written proof from an accredited medical institution, organization or
13 individual as to the need for the employee to donate bone marrow, a kidney, or other organs or tissue
14 or to participate in any other medical procedure where the participation of the donor is unique or
15 critical to a successful outcome.

16 **Section 2.** Time off from work for the purposes set out above in excess of five (5) working
17 days shall be subject to existing leave policies contained in this collective Bargaining Agreement.

1 **ARTICLE 12. LIMITED DUTY ASSIGNMENT DUE TO PREGNANCY**

2 **Section 1.** It is the policy of the County to recognize that pregnancy is a normal event in a
3 woman's life and that provisions shall be made to provide all female employees (full-time regular or
4 part-time regular) the opportunity to continue to participate in the work force during and up to three
5 (3) months after a pregnancy.

6 **Section 2.** A female employee, who upon the advice of her physician, cannot safely perform
7 all of the normal duties of her job due to pregnancy and who indicates a desire to continue working
8 prior to taking sick or maternity leave for which she may otherwise be eligible, shall upon
9 concurrence of the director receive consideration for temporary reassignment. The County shall,
10 where reasonably possible, accommodate a female employee's desire for medically approved
11 continued employment during pregnancy and up to three (3) months thereafter via one (1) or more of
12 the three (3) alternatives listed. The first alternative shall have preference and assignments and/or
13 reassignments shall be given within an employee's department where possible. The Human
14 Resources Division of the Department of Executive Services shall be responsible for coordination of
15 the following limited duty alternatives:

16 A. Temporary assignment to limited duties within the employee's classification;

17 B. Temporary reassignment of the employee to a similar classification with equal pay
18 for which the employee is qualified;

19 C. Only if the director concurs that an employee cannot reasonably be accommodated
20 by paragraphs Section 2.A or B in this Article, temporary reassignment of the employee can be made
21 to another classification for which the employee is qualified but with lesser pay, to be assigned at the
22 pay step closest to that which the employee was receiving in her normal job classification.

23 **Section 3.** The executive shall determine and facilitate any necessary interfund transfers when
24 an employee is temporarily reassigned to another department.

25 **Section 4.** Limitations.

26 A. Temporary assignments and/or reassignments made pursuant to this Article shall
27 be limited to the period of temporary incapacity caused by pregnancy both before childbirth and upon
28 return to work, all prior to the time when released by the employee's physician to return to full duty.

1 B. For the purposes of this Article, temporary incapacity is defined as the period
2 during which because of pregnancy the employee cannot perform all of her regular duties but is
3 capable of performing a temporary limited duty assignment provided by the County as listed in
4 Section 2 of this Article and, for purposes of this Agreement, in no instance shall such temporary
5 incapacity extend more than three (3) months after termination of the pregnancy.

6 C. Female employees shall continue to be eligible for paid accrued vacation and sick
7 leave and leave of absence without pay pursuant to the personnel rules and provisions of this
8 Agreement during the period of temporary incapacity due to pregnancy, pregnancy related conditions,
9 and parenting.

1 **ARTICLE 13: MEDICAL, DENTAL, LONG-TERM DISABILITY, AND LIFE INSURANCE**

2 **Section 1.** Eligible unit employees will participate in the County group Medical/Dental and
3 Life Insurance Programs.

4 **Section 2.** Medical/Dental and Life Insurance benefits shall be as provided for in the Labor-
5 Management Insurance Committee, which is comprised of representatives from the County and its
6 labor unions.

7 **Section 3.** The Union and the County agree to incorporate changes to employee insurance
8 benefits which the County may implement as a result of agreement of the Joint Labor-Management
9 Insurance Committee.

1 **ARTICLE 14: UNION REPRESENTATIVES**

2 **Section 1.** The Staff Representative of the Union may, after notifying the Health Department
3 official in charge, visit the work location of employees covered by this Agreement at any reasonable
4 time for the purpose of administering this Agreement. Such representative shall limit his/her
5 activities during such visits to matters relating to this Agreement. Department work hours shall not
6 be used by employees or Union representatives for the conduct of Union business or the promotion of
7 Union affairs.

8 **Section 2.** The County agrees that during working hours, on the County's premises, duly
9 authorized employee representatives of the Union shall be allowed to post and distribute Union
10 notices, attend authorized negotiations, joint labor management committee meetings, participate in
11 contract administration meetings and present a packet of Union information to new bargaining unit
12 members, with the prior or standing approval of management.

1 **ARTICLE 15: WORK OUTSIDE OF CLASSIFICATION**

2 **Section 1.** Whenever a regular employee is assigned by the Department Director or designee
3 to perform the duties of an employee at, or substantially the full duties of, a higher paid classification
4 for a period of four (4) consecutive hours or longer, he/she shall be paid at the rate established for
5 such classification while performing such duties. An employee shall continue to be paid at the out of
6 class rate while on a paid leave (i.e., vacation, sick leave, Holiday).

7 **Section 2.** Regular employees in a training capacity may be assigned work normally
8 performed by an employee in a higher classification, except that they will not be assigned the duties
9 of a higher classification to circumvent the intent of Section 1 hereof.

10 Any employee assigned to a training position shall be notified in writing one (1) working day
11 in advance by the department head or designee of his/her training status.

12 An employee assigned to a training position (training status) shall be under the supervision
13 and guidance of his/her immediate supervisor, and shall not remain in the training position for more
14 than ten (10) consecutive normal working days unless a longer training period is mutually agreed
15 upon in writing by the Union, Department and Human Resources Division Director of the
16 Department of Executive Services or designee.

17 **Section 3.** Employees covered by this Agreement may be temporarily assigned to perform the
18 duties of a lower classification without a reduction in pay.

19 **Section 4.** Employees who are substantially bilingual and are assigned in writing to regularly
20 use their skill in a language other than English in the performance of their work duties will be paid a
21 bilingual premium of \$50 per month. Such employees will be required to demonstrate their bilingual
22 ability, but are not required to be certified by the State of Washington as a translator/interpreter.
23 Language proficiency in each case will be assessed by staff from King County Superior Court
24 Interpreter Services. The County retains the right to contract for translators/interpreters as
25 appropriate.

1 **ARTICLE 16: HOURS OF WORK AND OVERTIME**

2 **Section 1.** Eight (8) hours shall constitute a normal day's work and five (5) consecutive days
3 a normal week's work.

4 **Section 2.** Alternative Work Schedules. It is hereby agreed that the Department may,
5 notwithstanding Section 1 of this Article, upon notice to the Union, agree to a 4/10 or other
6 alternative work schedules affecting employees covered by this Agreement, subject to such terms and
7 conditions as established by the Department. An alternative work schedule is defined as any schedule
8 of hours of work other than the traditional five eight-hour days within a seven day work week.

9 Examples of alternative work schedules include but are not limited to:

- 10 • 4/10 hour work days
11 • 9/8-off alternating work week schedule. (The record keeping time-sheet for this
12 schedule must be one which meets the FLSA standards dividing between two work weeks mid shift
13 on the fifth day of work which is either 8 hours or a day off.)

14 In administering the alternative work schedule, the following working conditions shall prevail:

- 15 • Overtime shall be paid for any hours worked in excess of forty (40) hours per week;
16 • Vacation benefits shall be accrued and expended on an hourly basis;
17 • Sick Leave benefits shall be accrued and expended on an hourly basis;
18 • Holidays shall be granted in accordance with Article 9 of this Agreement;
19 • Employee participation shall be on a voluntary basis;
20 • The department retains the right to modify or revoke such schedule. When
21 operationally feasible, the department will provide the employee at least thirty (30) days notice prior
22 to such change.

23 **Section 3.** Employees covered by this Agreement shall be provided a fifteen (15)-minute rest
24 period during each half of their workday.

25 **Section 4.** Employees covered by this Agreement shall be provided an uncompensated meal
26 time which shall not exceed one (1) hour.

27 **Section 5.** All work performed in excess of forty (40) hours in any work week or in excess of
28 the employee's regularly scheduled shift of not less than eight (8) hours shall be considered as

1 overtime and shall be paid for at the overtime rate of one and one-half (1-1/2) times the hourly regular
2 rate of pay.

3 Employees hired into the Psychiatric Evaluation Specialist (PES) or Administrative Specialist
4 II (AS II) classification on or after January 1, 2003 shall be covered under the Local 21-HD collective
5 bargaining agreement provisions for overtime. Employees hired into in the PES and Administrative
6 Specialist II classifications prior to January 1, 2003 shall be governed by the following:

7 Hours worked in excess of forty (40) hours in the work week shall be considered overtime,
8 and shall be paid at the overtime rate of one and one-half (1-1/2) times the hourly regular rate of pay.

9 "Hours worked" shall include the following:

- 10 • Vacation, when such vacations are pre-approved and prescheduled; and
- 11 • Mandatory training for employees who are ordered to attend training on a particular
12 date/time when such training cannot be rescheduled to a non-overtime period.

13 "Hours worked" does not include sick leave, holidays, and other paid leave.

14 **Section 6.** For employees covered by this Agreement, overtime shall be paid at either the
15 applicable overtime rate or by mutual consent between the employee and his/her supervisor,
16 compensated for by compensatory time off at the applicable overtime rate and in such a manner so as
17 not to conflict with the Fair Labor Standards Act (FLSA). In no event shall compensatory time taken
18 apply toward the FLSA workweek.

19 **Section 7.** Emergency Call Back. An employee covered by this Agreement who is called
20 back to work after completion of his/her regular shift or work week shall be granted at least the
21 equivalent of two (2) hours' pay at the applicable overtime rates.

22 All PES and AS II employees who are called back to work after completion of their regularly
23 scheduled shift shall be paid for such at the appropriate overtime rate. A minimum of four (4) hours
24 shall be paid to the employee or, where the actual hours worked exceeds four (4) hours, the employee
25 shall be paid for actual hours worked. Employees shall not be called out more than once in a twenty-
26 four (24)-hour period.

27 **Section 8.** When management deems it necessary, work schedules may be established other
28 than the normal Monday through Friday schedule.

1 **Section 9.** Two (2) days' advance notice shall be afforded employees covered by this
2 Agreement when shift changes are required by their supervisor.

3 **Section 10.** Meal Reimbursement (full-time regular or part-time regular).

4 A. When an employee is specifically directed by the Department to work two (2)
5 hours or longer prior to the beginning of or the end of his/her normal work shift of not less than eight
6 (8) hours and the employee actually purchases a reasonably priced meal away from the employee's
7 place of residence as a result of such additional hours of work, the employee shall be reimbursed for
8 the "reasonable cost" of the meal. In order to receive reimbursement, the employee must furnish the
9 Department with a receipt for the meal no later than the beginning of his/her next regular shift;
10 otherwise the employee shall be paid a maximum of ten dollars (\$10.00) in lieu of reimbursement for
11 the meal.

12 B. The Department shall not reimburse for the cost of alcoholic beverages.

13 C. In lieu of any meal compensation as set forth within this section, the Department
14 may, at its discretion, provide a meal.

15 When an employee (full-time regular or part-time regular) is called out in an emergency to
16 work two (2) hours or longer of unscheduled overtime immediately prior to his/her normal workshift,
17 said employee shall be eligible for meal reimbursement pursuant to this Section. Any time spent
18 consuming a meal during working hours shall be without compensation.

19 **Section 11.** Whenever an employee covered by this Agreement is placed on standby duty by
20 the Department, the employee shall be available at the predetermined location to respond to
21 emergency calls and, when necessary, return immediately to work. Employees who are placed on
22 standby duty by the Department shall be paid at the rate of ten (10) percent of the employees' straight
23 time hourly rate of pay for all hours assigned.

24 When an employee is required to return to work status while on standby duty, the standby pay
25 shall be discontinued for the actual hours on work duty and compensation shall be provided in
26 accordance with the provisions of this Article.

27 PES employees who are required to "stand by" for court appearances shall be compensated at
28 a rate of fifty (50) percent of their normal straight time hourly rate for all hours they are on standby

1 status on their regularly scheduled time off. Once notified that the employee must report to court, the
2 standby pay shall cease and the callback provision outlined above shall apply when the employee
3 reports to court if the report time meets the conditions described therein. If the employee is not
4 required to appear in court, a minimum of four (4) hours shall be paid at the standby rate.

5 **Section 12.** Psychiatric Evaluation Specialist (PES) Minimum Staffing Levels

6 As a guide to determining the granting of leave, the minimum PES staffing level at the Seattle
7 Facility will be two persons Monday through Friday roughly between the hours of 0800 and 1630. At
8 all other times, and all day on holidays, the minimum PES staffing level will be one person. Staffing
9 levels may go below minimum at the discretion of the supervising authority.

10 **Section 13.** Psychiatric Evaluation Specialist (PES) Master Schedule.

11 PES employees shall normally be scheduled pursuant to a master schedule. Prior to
12 implementing any large-scale changes to a PES master schedule, the employer agrees to meet and
13 discuss such with the Union. Any changes to a master schedule shall be posted for bid by the
14 employees for a period of time to be determined by the parties, but not to exceed fourteen (14)
15 calendar days. Upon completion of the bid process, employee assignments shall be posted, except in
16 emergency situations, at least fourteen (14) calendar days prior to implementation. If schedules have
17 not been changed for a period of three (3) consecutive years, then a schedule shall be opened for a
18 rebid.

19 **Section 14.** Bid Process.

20 When a Psychiatric Evaluation Specialist position becomes vacant or new positions are
21 created, PES employees shall have the opportunity to bid, based upon seniority, for the shift and days
22 off of the position. Seniority is defined as total unbroken service in the same job classification or
23 classification series as measured by date in present job classification. Prospective upon
24 implementation of this Agreement, time served as a Temporary Employee (as calculated by the
25 Union) shall count toward seniority if there is no break in service when hired into a career service
26 position in the same job classification. Notwithstanding future breaks in service or unpaid leaves of
27 absence, Psychiatric Evaluation Specialist shall retain their seniority status held on January 1, 2005
28 for purposes of bidding. A break in service is a voluntary quit, retirement or termination for just

1 cause. Authorized paid and unpaid leaves of absence are not breaks in service; however, seniority
2 will not continue to accrue after an unpaid leave exceeds thirty (30) consecutive days. Employees
3 who transfer or promote to a different bargaining unit job classification without a break shall retain
4 accrued seniority in the previous classification, and begin to accrue seniority in the new classification
5 from the date of the probationary appointment.

1 **ARTICLE 17: TRANSFER, VOLUNTARY REDUCTION, AND LAYOFF**

2 **Section 1. Definitions.** The following definitions shall apply for the purposes of
3 administering this Article.

4 **A. Seniority** is defined as total unbroken service in the same job classification or
5 classification series as measured by date in present job classification. Prospective upon
6 implementation of this Agreement, time served as a Temporary Employee (as calculated by the
7 Union) shall count toward seniority if there is no break in service when hired into a career service
8 position in the same job classification. Notwithstanding future breaks in service or unpaid leaves of
9 absence, Psychiatric Evaluation Specialist shall retain their seniority status held on January 1, 2005
10 for purposes of layoffs. A break in service is a voluntary quit, retirement or termination for just
11 cause. Authorized paid and unpaid leaves of absence are not breaks in service; however, seniority
12 will not continue to accrue after an unpaid leave exceeds thirty (30) consecutive days. Employees
13 who transfer or promote to a different bargaining unit job classification without a break shall retain
14 accrued seniority in the previous classification, and begin to accrue seniority in the new classification
15 from the date of the probationary appointment. Employees who leave Health Department
16 employment as a result of layoff may retain accrued seniority when they return to Health Department
17 employment within two years of layoff. Employees that incur a break in service as defined in this
18 section that return to a bargaining unit position begin anew their classification and classification
19 series seniority.

20 **B. Position Elimination/Change in FTE** is any County initiated elimination,
21 involuntary reduction or involuntary increase in the work hours (not to include overtime) for a
22 position that for seniority reasons does not constitute a layoff for the employee. Prior to the
23 Department implementing a change in FTE, the employee subject to change in FTE shall be provided
24 with the "Position Elimination/Change in FTE Notice" options set forth in Section 4 of this Article.
25 Employees occupying positions where "Temporary" increases or decreases in FTE last longer than six
26 months shall be provided with the "Change in FTE Notice" options set forth in Section 4 of this
27 Article.

28 **C. Layoff** is the involuntary elimination or reduction of work hours (FTE) for the

1 employee(s) with the least amount of classification series seniority. An involuntary increase in the
2 standard working hours of a position shall create the same vacancy and bumping rights for employees
3 whose hours are increased as are created by the terms of this Article for employees in a
4 layoff/reduction in force situation.

5 **D. Qualified** means the employee possesses the qualifications (as determined by the
6 job description) required to be considered eligible to be appointed to the classification as a new hire.

7 **Section 2. Transfer.**

8 **A.** The transfer of an employee shall not constitute a promotion except as provided in
9 Article 17, Section 2 (E) (3).

10 **B. Transfers within the Department of Public Health.** The Department of Public
11 Health Director or his or her designee may transfer a Public Health employee from one position to
12 another position in the same classification within the Department without the approval of the Human
13 Resources Division Director of DES, or designee, but such transfer shall be reported to Human
14 Resources Division Director of DES, or designee within five (5) days of its effective date. It is
15 understood by the parties that employees may be transferred at the discretion of the County in
16 consultation with the Union as part of the budget planning process. The budget planning process
17 concludes at the point the County Executive submits his or her budget to the King County Council.

18 **C. Transfers from County departments into Public Health.** Employees in County
19 departments may transfer, if qualified, to a position in the same classification, or to a position in a
20 similar classification with the same maximum rate of pay, within the Department of Public Health
21 upon the written request of the Public Health Director and approval by the DES, Human Resources
22 Division Director or designee.

23 **D. Transfers from Public Health to County departments.** Any transfer from a
24 position in Public Health to a position in the same or similar classification with the same maximum
25 rate of pay within a County department shall be subject to the applicable County rules, policies,
26 procedures (and any applicable County collective bargaining agreement), which sets forth the terms
27 and conditions for transfers within the County personnel system.

28 **E. Other transfers.** Within the Department of Public Health, other transfers may be

1 made upon the consent of the Public Health Director and with the approval of the DES, Human
2 Resources Division Director, or designee, as follows:

3 1. Transfer to another classification in the Department of Public Health in case
4 of injury in line of duty either with Public Health or with the armed forces in time of war, resulting in
5 permanent partial disability, where showing is made the transferee is capable of satisfactorily
6 performing the duties of the new position.

7 2. Transfer, in lieu of layoff, may be made to a single position in another
8 classification in the Department upon showing that the transferee is capable of satisfactorily
9 performing the duties of the position, and that a regular employee or probationer is not displaced.
10 The affected employee shall complete a probationary period in the new classification.

11 3. Transfer, in lieu of layoff, may be made to a single position in another
12 classification when such transfer would constitute a promotion or advancement in the service
13 provided a showing is made that the transferee is capable of satisfactorily performing the duties of the
14 position and that a regular employee or probationer is not displaced and when transfer in lieu of layoff
15 under Section 2(E)(2) of this Article is not practicable. Regular standing in the new classification
16 may be attained by the employee only through examination and permanent regular appointment.

17 4. Transfer may be made to another similar classification within Public Health
18 with the same maximum rate of pay in the Department. The affected employee's status shall be
19 determined in accordance with Article 21, Section 4 of this Agreement.

20 **Section 3. Voluntary Reduction.**

21 A. A regularly appointed employee may be reduced to a lower classification upon
22 his/her written request stating his/her reasons for such reduction, if the request is concurred with by
23 the Public Health Director and is approved by the DES, Division of Human Resources Director, or
24 designee. Such reduction shall not displace any regular employee or probationer.

25 B. The employee so reduced shall be entitled to credit for previous regular service in
26 the lower classification and to other service credit in accordance with Article 18, Section 5. Upon a
27 showing, concurred with by the Public Health Director that the reason for such voluntary reduction no
28 longer exists, the DES, Human Resources Division, or designee, may restore the employee to his/her

1 former status.

2 **Section 4. Notice of Anticipated Position Elimination/Change of FTE**

3 The following process shall govern for the purposes of administering this Section.

4 A. When the Department determines there is a need to eliminate, reduce, or increase
5 the working hours of existing filled positions (change in FTE), the Department shall identify by job
6 classification and work site which position(s) are to be eliminated, decreased or increased. The
7 Department agrees to notify the Union at least thirty (30) days in advance, in writing, of any
8 anticipated change in filled FTE. The Department will provide the following information to the
9 Union at least thirty (30) days in advance: the names, classification, and seniority information of
10 employees effected by a change in filled FTE; a seniority list for the classification impacted and a list
11 of all vacant positions within the classification; a list of all probationary, TLT, Temporary and any
12 other provisional positions within the classification. The Department will hold the relevant positions
13 frozen until the entire process has been completed.

14 B. An incumbent employee in a position impacted by a change in FTE shall be
15 notified by the department at least thirty (30) calendar days prior to the effective date of the change.
16 The notice will include information about the options provided in this Section. A copy of the notice
17 will be provided to the Union. The employee shall be allowed fourteen (14) calendar days to elect
18 one of the following options:

19 1. The employee may request placement in a vacant position within the
20 bargaining unit. In the case of an involuntary increase or decrease in hours, an affected employee
21 shall be given first right of refusal over the increased or decreased hours before such position is
22 posted. The Department must offer a vacant bargaining unit position of the same classification to an
23 employee subject to a change in FTE, if the Department intends to fill the position. The Department
24 will inform the employee and the union of all, available vacant bargaining unit positions that the
25 Department intends to fill.

26 2. The employee may request placement into a vacant bargaining unit position
27 in another job classification, provided the employee is qualified.

28 3. The employee may displace (bump) the least senior employee in the same

1 job classification and equally budgeted FTE that does not result in a layoff provided the employee has
2 more classification seniority than the incumbent employee. If an equally budgeted FTE position does
3 not exist, then the employee may displace (bump) the least senior employee in the job classification
4 with the most equivalent FTE or may bump the least senior employee in the classification.

5 4. The employee may on the basis of total bargaining unit seniority, bump the
6 least senior employee (regardless of FTE status), in any job classification previously worked in the
7 bargaining unit or classification series, provided that a successful probationary period has been
8 completed in that classification.

9 5. An employee may choose to be laid off rather than exercise the options
10 above.

11 C. When the Department determines to eliminate, reduce, or increase the hours of
12 multiple positions, the incumbents in the positions to be affected shall be notified at least thirty
13 calendar days prior to the effective date. The notice will include information about the options
14 provided in Article 18, Section 4(B). A copy of the notice will be provided to the Union. The
15 employees shall be allowed fourteen calendar days to select their options under Article 18, Section
16 4(B) using the following procedure:

17 1. The employees will designate a first, second and third choice among the
18 options 1 through 5 of Article 18, Section 4(b);

19 2. Option choices will be allocated in order of seniority, the most senior
20 employee having priority; provided, however, bumping choices will be allocated according to item 3
21 below, and vacant positions will be allocated according to item 4 below.

22 3. It is the intent for bumping to proceed in reverse seniority order; that is, the
23 least senior employee will be displaced first. No employee may be bumped ahead of the least senior
24 employee in the same job classification and same FTE. The Department will provide employees
25 subject to change in FTE with a list of positions held by the least senior employees within the
26 employees' job classification; the number of such positions will be equal to the number of positions
27 to be eliminated in that job classification. An employee may designate as an option a position from
28 this list which is not held by the least senior employee; however, the option will not be available

1 unless the lower-seniority employee(s) on the list is (are) displaced.

2 4. If two or more employees select the same vacant position, the position will
3 be offered to the most senior employee. An employee may choose to be laid off rather than
4 exercising the options above.

5 **Section 5.** Layoff.

6 A. Employees laid off as a result of a reduction of work and/or a shortage of funds
7 shall be laid off according to seniority within classification within the Department regardless of FTE
8 status.

9 Reduction of hours of any position covered under this agreement will be considered a layoff
10 and subject to the provisions of this section. Employees with the least amount of seniority shall be
11 the first laid off and receive a layoff notice; however, in the event of two (2) employees having the
12 same seniority, ability and skill shall be the determining factor on retention. An employee designated
13 for layoff within a specific classification may on the basis seniority, bump the least senior employee
14 (regardless of FTE status), in any job classification previously worked in the bargaining unit or
15 classification series, provided that a successful probationary period has been completed in that
16 classification or displace a Term Limited Temporary (TLT) employee or temporary employee
17 working in the current classification or any job classification previously worked in the bargaining unit
18 or classification series. Any employee bumping into a TLT or temporary position shall maintain their
19 layoff/recall rights pursuant to Section C and shall continue to accrue seniority and maintain step
20 placement. The transfer of a regular employee into a TLT or temporary position shall not convert
21 such position to a regular, career service position.

22 B. A previously laid off employee recalled to a previously held classification due to
23 layoff/bumping shall be credited with total cumulative service in that classification for the purpose of
24 determining classification seniority.

25 C. Employees laid off shall be recalled to an equivalent classification or lower
26 classification (if qualified) in the inverse order of layoff, prior to any new employees being appointed
27 to that classification i.e., those with the most seniority being recalled first. Recall rights to the
28 classification from which an employee has been laid off shall expire two (2) years from the date of

1 layoff.

1 **ARTICLE 18: SAFETY STANDARDS**

2 All work shall be done in a competent and safe manner and in accordance with the state of
3 Washington Safety Codes and the County's standards.

4 One employee representative may be designated to represent the Union on the Department's
5 Field Worker Safety Committee.

1 **ARTICLE 19: GENERAL CONDITIONS**

2 **Section 1.**

3 A. All employees who have been authorized to use their own transportation on
4 County business shall be reimbursed at the basic mileage reimbursement rate established by the King
5 County Council by Ordinance for the first two hundred (200) miles per month. Employees required
6 to travel in excess of two hundred miles per month shall be reimbursed for all miles above two
7 hundred at a rate which is two cents (2 cents) per mile greater than the basic mileage reimbursement
8 rate but shall not exceed the IRS allowable rate. Claims shall be made on a monthly basis on a form
9 prescribed by the Department.

10 B. Should the County Council increase the basic mileage reimbursement rate for other
11 County employees during the term of this Agreement, then the same rate will be extended to
12 employees covered by this Agreement.

13 **Section 2.** Whenever an employee covered by this Agreement is temporarily assigned by the
14 Department Director or designee to work, i.e., perform his/her regular duties, at a location other than
15 his/her normal place(s) of employment, any time, less meal time, consumed in traveling to and from
16 the new location, shall be considered part of the workday. Any time consumed in this travel, less
17 meal time, which is outside of the employee's regular working hours, shall be compensated at the
18 applicable overtime rate.

19 The above provision does not apply to travel time from one's usual place of residence to the
20 place of work, nor does it apply to travel time for seminars, conventions, etc., unless specifically
21 authorized in writing by proper authorities.

22 **Section 3.** Child Care Subsidy. Employees covered by this Agreement may receive benefits
23 from the County's child care program if they meet the eligibility requirements.

24 **Section 4.** Bulletin Boards. The County agrees to permit the Union to post on County
25 bulletin boards the announcement of meetings, election of officers, and any other material relating to
26 Union activities so long as that material does not support or oppose political candidates or political
27 issues.

28 **Section 5.** Bus Passes. Benefit-eligible employees covered by this agreement shall receive

1 metro bus passes.

2 **Section 6.** Psychiatric Evaluation Specialists who request shall have materials relating to
3 corrective counseling removed from the employee's file after a twelve (12) month period unless
4 another act of misconduct has been committed during the twelve (12) month period.

5 **Section 7.** License/Certification: Psychiatric Evaluation Specialists who are required to be
6 licensed or certified as a condition of employment will have their license renewal fees reimbursed by
7 the Department.

8 **Section 8.** The County shall not use "short term" temporary or term-limited temporary
9 employees to supplant regular career service positions in the bargaining unit.

10 **Section 9.** Where those duties covered by this Agreement are assigned to a different or new
11 classification in the Department, the Union will continue to be recognized as exclusive bargaining
12 representative for those duties. Any disagreement between the parties over the application of this
13 section shall be processed and settled pursuant to RCW 41.56, WAC 391-35.

14 **Section 10.** The Department may establish on-the-job training program(s) in a different
15 classification and/or within another bargaining unit for the purpose of providing individuals an
16 opportunity to compete and potentially move laterally and/or upward into new career fields. Prior to
17 implementation of such a program(s) relative to bargaining unit employees, the Department shall
18 discuss the program(s) with the appropriate Union or Unions and the issue of bargaining unit
19 jurisdiction and/or salary shall be a proper subject for negotiations at that time upon the request of
20 either party.

21 **Section 11.** Training. The County recognizes the importance and value of providing training
22 opportunities. To that end, the department will continue to make every effort to allow employees
23 reasonable release time to attend training sessions and seminars in their field. In addition, the
24 department will continue to explore methods of providing training sessions and presentations in-
25 house to bargaining unit employees. Employees shall be entitled to a minimum of 3 days of paid
26 leave time annually for the purpose of attending training that is job related.

27 **Section 12.** The Department shall have the right to implement new public employment
28 programs or expand its current programs beyond what exists as of the signature date of this

1 Agreement. Where such implementation or expansion involves bargaining unit work and results in a
2 significant departure from existing practice, the Department shall give thirty (30) days' advance
3 written notice to the Union of such. Upon receipt of a written request from the Union thereafter, the
4 Department shall engage in discussions with the Union on concerns raised by the Union.
5 Notwithstanding any provision to the contrary, the expanded use of individuals under such a public
6 employment program which involves the performance of bargaining unit work with the Department,
7 beyond what has traditionally existed, shall not be the cause of (1) a layoff of regular employees
8 covered by this Agreement, or (2) the abrogation of a regular budgeted full-time position covered by
9 this Agreement which recently had been occupied by a regular full-time employee that performed the
10 specific bargaining unit work now being or about to be performed by an individual under one of the
11 Department's public employment programs.

1 **ARTICLE 20: PROBATIONARY PERIOD**

2 **Section 1.** The following shall define terms used in this Article:

3 **Probationary employee** means an employee serving a probationary period in a regular
4 career service position. Probationary employees are temporary employees and excluded from career
5 service under Section 550 of the charter.

6 **Probationary period.** There shall be a probationary period during which time a
7 probationary employee shall be evaluated by the appointing authority to determine qualification for
8 entry into the career service. The probationary period shall be determined by the Human Resources
9 Director, but shall be not less than six months or more than one year of actual service, and shall be
10 served by those employees who have been newly-hired, demoted to a classification where a
11 probationary period has not been served, reinstated to a classification where a probationary period has
12 not been served or transferred to a classification where a probationary period has not been served,
13 reemployed, or promoted (except as a result of reclassification). An employee's probationary period
14 may be extended up to six (6) additional months by written mutual agreement between the
15 Department, the employee, and the Union, subject to approval by the Department of Executive
16 Services Director or designee prior to the expiration of the initial six (6)-month probationary period.

17 Full-time regular or part-time regular employee: An employee who has successfully
18 completed a six month probationary period and has had no subsequent break in service as occasioned
19 by quit, resignation, discharge for just cause, or retirement.

20 **Section 2.** Probationary Period/Status of Employee.

21 Employees who are appointed to regular career service positions shall serve a probationary
22 period of six months, at which time they shall become regular employees.

23 A. The probationary period shall provide the Department with the opportunity to
24 observe a new employee's work, to train and aid the new employee in adjustment to the position, and
25 to terminate any employee whose work performance fails to meet the required standards.

26 B. An employee shall become regular after having completed the probationary period
27 unless the individual is dismissed under provisions of Section 3 below.

28 C. If an employee hired into a higher classification performed the work as a special

1 duty assignment, the appointing authority may allow the time spent performing the work to satisfy the
2 probationary requirement.

3 **D.** A temporary career service exempt employee who accepts a career service position
4 may, at the discretion of the appointing authority, count all continuous employment in the same
5 position or performing the same work toward satisfying the probationary period requirement.

6 **Section 3.** Probationary Period/Dismissal.

7 An employee dismissed during the probationary period shall not have the right to appeal the
8 dismissal. When proper advance notice of the dismissal is not given, the employee may enter an
9 appeal (for payment of up to five days' salary) which the employee would have otherwise received
10 had proper notice been given. If such a claim is sustained, the employee shall be entitled to the
11 appropriate payment of salary but shall not be entitled to reinstatement.

12 **Section 4.** Transfers During Probationary Period.

13 If a probationary employee is transferred to a different classification in the Health
14 Department, the employee shall serve a complete probationary period in the new classification.

15 **Section 5.** The probationary period shall be equivalent to six months of service following
16 appointment to a budgeted, career service position. Occasional absences due to illness, vacations, and
17 military leaves shall not result in an extension of the probationary period, but upon approval of the
18 Human Resources Division Director of the Department of Executive Services, an employee's
19 probationary period may be extended so as to include the equivalent of a full six months of actual
20 service where there are numerous absences.

21 **Section 6.** If the Department determines that the employee will not complete the probation
22 period for a position to which the employee has promoted, demoted to a classification where a
23 probationary period has not been served, reinstated to a classification where a probationary period has
24 not been served or transferred to a classification where a probationary period has not been served, or
25 if the employee chooses not to complete this probation period, the employee is eligible to return
26 (revert) to the former position (or equivalent) if there is a vacancy. However, other employees will
27 not be removed to create a vacancy for the employee. If the employee's former position is not
28 available, the employee will be terminated from employment and his/her name will be placed on a

1 bargaining unit recall list for a period of two years from the date of termination. Employees refusing
2 placement to a position under this article in the same classification and FTE shall forfeit their recall
3 rights arising under this section.

1 **ARTICLE 21: LABOR-MANAGEMENT MEETINGS**

2 The County, Department and the Union agree to hold Labor/Management meetings as
3 necessary. These meetings will be called upon request of either party to discuss any subject of a
4 general nature affecting employees covered by this agreement, including but not limited to safety
5 issues. The responsibility for notification will be with the party initiating this process.
6 Representatives of the Health Department can attend such meetings and shall be able to
7 independently set such meetings with the Union with the concurrence of the Human Resources
8 Division Director of the Department of Executive Services or designee. The Union shall be permitted
9 to designate members and/or stewards to assist its staff representatives in such meetings.

10 The purpose of Labor/Management meetings is to deal with matters of general concern to the
11 Union and the Department. It is understood that such meetings are consultative in nature.

1 **ARTICLE 22: SUBORDINATION OF AGREEMENT**

2 **Section 1.** It is understood that the parties hereto and the employees of the Department are
3 governed by the provisions of applicable federal law and state law. When any provisions thereof are
4 in conflict with or are different than the provisions of this Agreement, the provisions of said federal
5 law or state law are paramount and shall prevail.

6 **Section 2.** It is also understood that the parties hereto and the employees of the Department
7 are governed by applicable County Ordinance and County Charter and said ordinances and charters
8 are paramount except where they conflict with the expressed provisions of this Agreement.

1 **ARTICLE 23: SAVINGS CLAUSE**

2 **Section 1.** If any article of this Agreement or any addenda thereto is held invalid by operation
3 of law or by any tribunal of competent jurisdiction, or if compliance with, or enforcement of, any
4 article is restrained by such tribunal, the remainder of this Agreement and addenda shall not be
5 affected thereby, and the parties shall enter into immediate collective bargaining negotiations for the
6 purpose of arriving at a mutually satisfactory replacement for such article.

1 **ARTICLE 24: ENTIRE AGREEMENT**

2 **Section 1.** The Agreement expressed herein in writing constitutes the entire Agreement
3 between the parties, and no oral statement shall add to or supersede any of its provisions.

4 **Section 2.** The parties acknowledge that each has had the unlimited right and opportunity to
5 make demands and proposals with respect to any matter deemed a proper subject for collective
6 bargaining. The results of the exercise of that right are set forth in this Agreement. Therefore, except
7 as otherwise provided in this Agreement, each voluntarily and unqualifiedly agrees to waive the right
8 to oblige the other party to bargain with respect to any subject or matter, whether or not specifically
9 referred to or covered in this Agreement.

1 **ARTICLE 25: DEFINITIONS**

2 **Section 1.** "Short term" Temporary employees shall be paid for all hours worked at the first
3 pay step of the hourly rate of pay set forth within Addendum A covering the classification of work in
4 which he/she is employed. Any exception must be approved in writing by the Director of Public
5 Health with notice to Local 21.

6 **Section 2.** A temporary employee shall pay to the Union, in lieu of the Union security
7 requirement under Article 4, a service fee in an amount equal to the Union's regular dues uniformly
8 required of regular Department employees.

9 **Section 3.** A "short term" temporary employee, other than probationary or term-limited, who
10 exceeds the calendar year limit of 1040 work hours will be eligible for compensation in lieu of leave
11 benefits at the rate of fifteen percent (15%) of gross pay for all hours worked, retroactive to the first
12 hour of employment and for each hour worked thereafter, and compensation in lieu of insured
13 benefits as provided in the King County Code.

14 **Section 4.** "Short term" temporary employees and term-limited temporary employees who
15 have worked in excess of 520 straight time hours within the previous twelve-month period, and who
16 are appointed to a regular position without a break in service shall have his/her time worked within
17 the previous twelve-month period counted for purposes of salary step placement.

1 **ARTICLE 26: TERM OF AGREEMENT**

2 **Section 1.** This Agreement shall become effective upon the effective date of the ordinance
3 approving this Agreement and shall cover the period from January 1, 2006 through December 31,
4 2008. Written notice of intent to terminate or modify this Agreement must be served by the
5 requesting party at least ninety (90) days, but not more than one hundred and twenty (120) days, prior
6 to December 31, 2008.

7 **Section 2.** In the event that negotiations for a new Agreement extend beyond the anniversary
8 date of this Agreement, the terms of this Agreement shall remain in full force and effect until a new
9 Agreement is consummated or unless either party serves the other party with ten (10) days'
10 notification of intent to terminate the existing Agreement.

MEMORANDUM OF AGREEMENT

King County and the Union (the parties) agree to a Cost of Living Adjustment for the January 1, 2005 through December 31, 2005 time period in the following manner:

1. Pay Adjustment

Existing bargaining unit members and bargaining unit members enrolled in the County's Career Support Services recall placement service at the time this agreement is implemented by the County will receive on the first regular pay period following enactment of this agreement a 2.19% cost of living adjustment retroactive to January 1, 2005.

2. Normal Withholding

All payments made pursuant to this Memorandum of Agreement shall be subject to regular and legally required withholdings including deductions for purposes of the Public Employment Retirement System (PERS). King County shall be responsible to the Department of Retirement Systems (DRS) for payment of PERS contributions. Each individual shall be responsible to King County for repayment of the employee's share of their PERS contribution. Each individual shall have the PERS employee obligation deducted from the lump sum and mitigation payments.

3. Effective Date

The parties agree that this Memorandum of Agreement shall become effective with the King County Council's approval by ordinance.
