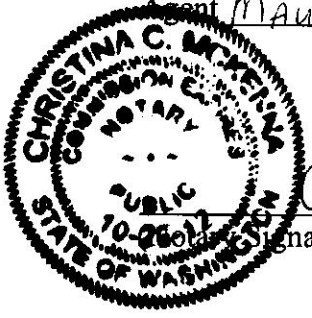

Proposed Ordinance 2012-0250**

NOTICE IS HEREBY GIVEN that a public hearing will be held before the Metropolitan King County Council, Room 1001, King County Courthouse, Seattle, Washington on the 10th day of September, 2012 at 1:30 p.m., to consider adoption of Proposed Ordinance No. 2012-0250 which would authorize the issuance by the County of limited tax general obligation bonds in an aggregate principal amount not to exceed \$56,000,000 (the "Bonds"). The proceeds of the Bonds will be used to provide for the refunding and defeasance of the Broadway Office Properties Lease Revenue Bonds (King County, Washington Project), 2002 (the "BOP Bonds"). The BOP Bonds were originally issued by Broadway Office Properties, a nonprofit corporation, on behalf of the County, for the acquisition, construction and equipping of an office building located at 401 Broadway, Seattle, Washington (the "Pat Steel Building"). The County will be the initial owner of the Pat Steel Building following the issuance of the Bonds. Testimony will be taken from all members of the public attending the hearing. Prior to the meeting, written comments may be sent to Nigel Lewis, Senior Debt Analyst, 509 Fourth Avenue, Room 611, Seattle, Washington 98104. Written comments may also be sent to the Council at clerk.council@kingcounty.gov.
