1	AN ORDINANCE relating to the annexation of an area
2	known as South 272nd Way/South Star Lake Road to
3	Lakehaven Utility District for the purpose of providing
4	sewer service.

7	STATEMENT OF FACTS:
8	1. A notice of intention proposing the annexation of an area known as
9	South 272nd Way/South Star Lake Road for sewer service was filed with
10	the county council on October 23, 2002.
11	2. Lakehaven Utility District has found the petition for annexation to be
12	sufficient and has concurred with the proposed annexation in Resolution
13	No. 2002-980.
14	3. Lakehaven Utility District issued a determination of nonsignificance on
15	the proposed annexation dated July 22, 2002.
16	4. The utilities technical review committee recommended county council
17	approval of the proposed annexation on November 13, 2002.

18	5. The county council held a public hearing on December 9, 2002 and has
19	considered the criteria in RCW 57.02.040(3).
20	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
21	SECTION 1. Findings. The county council finds that:
22	A. The proposed action is in compliance with the county's Comprehensive Plan;
23	B. The proposed action is in compliance with the policies expressed in the
24	district's plan for water or sewage facilities, or both.
25	SECTION 2. After consideration of the criteria listed in RCW 57.02.040(3), the
26	annexation by Lakehaven Utility District of the area known as the South 272nd
27	Way/South Star Lake Road Annexation and described in Attachment A to this ordinance
28	is consistent with those criteria and is approved. Pursuant to RCW 57.02.045, this
29	approval is final unless review is taken by the King County boundary review board under
30	chapter 36.93 RCW.
31	SECTION 3. Lakehaven Utility District is the appropriate entity to serve the area
32	proposed to be annexed.
33	SECTION 4. Completion of this annexation does not constitute county approval

or disapproval of any other permits, certifications or actions necessary to provide service to this annexation area.

LEGAL DESCRIPTION

2002 545

ANNEXATION SOUTH 272ND WAY/SOUTH STAR LAKE ROAD (Between 49th Avenue South and 55th Avenue South) CORPORATE AND SEWER ONLY

Those portions of the Northeast quarter of Section 34, Township 22 North, Range 4 East, W.M., in King County, Washington, and of the Northwest and Southwest quarters of Section 35, Township 22 North, Range 4 East, W.M., King County, Washington, more particularly described as follows:

BEGINNING at the Northwest corner of the Southeast quarter of the Northeast quarter of said Section 34;

THENCE easterly 375 feet, more or less, along the North line of said subdivision to its point of intersection with the northerly margin of South Star Lake Road;

THENCE northeasterly, easterly, and southeasterly along said northerly margin to its point of intersection with the North line of the Southeast quarter of the Northeast quarter of said Section 34;

THENCE easterly along said North line 650 feet, more or less, to the Northeast corner of said subdivision;

THENCE southerly along the East line of said subdivision, 435 feet, more or less, to the northerly margin of South Star Lake Road;

THENCE southeasterly along said northerly margin of South Star Lake Road to its point of intersection with the East line of the West half of the Southwest quarter of the Northwest quarter of Section 35, Township 22 North, Range 4 East, W.M., King County, Washington;

THENCE northerly along said East line of said subdivision, 250 feet, more or less, to its point of intersection with the South line of the North 238 feet of the East half of the Southwest quarter of the Northwest quarter of Section 35, Township 22 North, Range 4 East, W.M., King County, Washington;

THENCE easterly along said South line of said subdivision to its point of intersection with the southerly margin of South 272nd Way;

THENCE southeasterly along said southerly margin of South 272nd Way to its point of intersection with the East line of said subdivision;

THENCE northerly along said East line of said subdivision to the northerly margin of South 272nd Way at its point of transition to the northeasterly margin of South 272nd Way/South 277th Street;

THENCE southeasterly along said northeasterly margin of South 272nd Way/South 277th Street to its point of intersection with the northwesterly projection of the easterly margin of 55th Avenue South;

THENCE southeasterly, southerly and southwesterly along said easterly margin of 55th Avenue South to a point that lies 170 feet due East of the West line of the Northeast quarter of the Southwest quarter of said Section 35;

THENCE northerly in a straight line and parallel to said West line, to its point of intersection with the North line of said subdivision:

THENCE westerly along said North line to the Southeast corner of the Southwest quarter of the Northwest quarter of said Section 35;

THENCE continuing westerly along the South line of said subdivision to its point of intersection with the West line of the East half of the East half of said subdivision;

THENCE northerly along said West line to its point of intersection with the centerline of South Star Lake Road;

THENCE northwesterly along said centerline of South Star Lake Road to its point of intersection with the West line of the Southeast quarter of the Northeast quarter of said Section 34;

THENCE northerly along said West line to the POINT OF BEGINNING.


