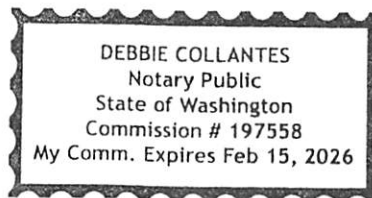

NOTICE IS HEREBY GIVEN, that a public hearing will be held before the Metropolitan King County Council on the 23rd day of August, 2022, at 1:00 p.m. to consider adoption of Proposed Ordinances: 2022-0297, which will determine whether King County Fire Protection District No. 24 is inactive and whether it should be dissolved; 2022-0298, which will determine whether Coalfield Park and Recreation Service Area is inactive and whether it should be dissolved; 2022-0299, which will determine whether Enumclaw Park and Recreation Service Area is inactive and whether it should be dissolved; 2022-0301, which will determine whether Shoreline Park and Recreation District is inactive and whether it should be dissolved; and, 2022-0303, which will determine whether Issaquah Park and Recreation Service Area is inactive and whether it should be dissolved. A public hearing is planned for each of these proposed ordinances to be held at the King County Courthouse, 516 3rd Ave, Room 1001, Seattle, Washington; and/or the hearing may be held remotely on Zoom. - Dissolve Shoreline Park and Recreation District

Proposed Ordinance 2022-0303 if adopted will:

- Make a finding that Issaquah Park and Recreation Service Area is inactive
- Dissolve Issaquah Park and Recreation Service Area
