The Healthy Housing Guidelines and Recommendations are intended to inform governmental officials working at regional, county and city levels on housing strategies and policies to improve the health of residents and communities while preserving housing affordability throughout King County. Guidelines and recommendations are advisory only, and do not have the force and effect of law.

A public hearing on the proposed guidelines and recommendations at which the public may state their views orally or in writing will be held during the regular meeting of the King County Board of Health, March 16, 2017 in the Metropolitan King County Council Chambers, 10th floor, Courthouse, 516 Third Avenue, Seattle, WA.
