*June 19 – Regular meeting of the TREE Committee. Agenda includes discussion and opportunity for public testimony on the Executive's 2012 proposed changes to the Comprehensive Plan. Expected to be discussed: fiscal analysis, Area Zoning studies, follow up issues & Comments from UACs, and Agriculture and Forestry Commission.*

*July 17 – 2012 Comprehensive Plan Review Committee. Agenda includes discussion on the Executive's 2012 proposed changes to the Comprehensive Plan. Chair's striking amendment should be released during the week of July 3. Striking amendment and amendments to the striker are expected to be the subjects of this meeting.*

*July 25 – 2012 Comprehensive Plan Review Committee. Discussion and possible action on 2012 Comprehensive Plan. TREE is expected to complete its recommendation on the 2012 Comprehensive Plan and forwards it on to the full Council. Opportunity for public testimony will be available.*

*July 31 - Regular meeting of TREE Committee scheduled.*

*September 10 (anticipated) – Public hearing and testimony before the full council on the TREE recommended 2012 Comprehensive Plan.*

*September 17 (anticipated) – Full Council: Final Action on TREE recommended 2012 Comprehensive Plan.*

*September 24 (REVISED) (anticipated) – Transmittal of Executive Proposed 2013 Budget. Transmittal of CONCURRENCY MAP, COUNTY'S CAPITAL IMPROVEMENT PROGRAMS SIX YEAR PLANS & School Capital Facilities Plans. Note: The public is given an opportunity to testify on these elements of the Comprehensive Plan in conjunction with review of the 2013 Budget.*

*November 19 (anticipated) – Public hearing at the full Council on 2013 Budget, including Capital Improvement Program.*

*November 19 (REVISED) (anticipated) – Final adoption of the School Capital Facilities Plans, COUNTY'S CAPITAL IMPROVEMENT PROGRAMS SIX YEAR PLANS and CONCURRENCY MAP conjunction with adoption of the 2013 Budget.*
