Ordinance 18810

NOTICE IS HEREBY GIVEN that the Metropolitan King County Council (the Council) held a public hearing in the Council Chambers on the 10th Floor of the King County Courthouse (516 Third Avenue, Seattle, WA) on Monday, October 29, 2018, beginning at 1:30 PM. The purpose of this public hearing was to consider adoption of Proposed Ordinance 2018-0153 (Ordinance 18810) adopting 2018 amendments to the 2016 King County Comprehensive Plan (KCCP).

SUMMARY:

Proposed updates to the KCCP were transmitted by the King County Executive on March 1, 2018. The updates were reviewed by the Planning, Rural Service and Environment Committee, which adopted amendments and made its recommendation on September 12, 2018. Council action took place on October 29, 2018.
