# 4. Proposed Ordinance No. 2018-0086

AN ORDINANCE related to the cultural development authority; identifying responsibilities of the county council; amending Ordinance 14482, Section 34, and K.C.C. 2.46.180, Ordinance 8300, Section 3 as amended, and K.C.C. 2.48.030, Ordinance 14482, Section 38, and K.C.C. 2.48.065, Ordinance 14482, Section 39, and K.C.C. 2.48.075, Ordinance 14482, Section 40, and K.C.C. 2.48.085, Ordinance 14482, Section 5, as amended, and K.C.C. 2.49.020, Ordinance 14482, Section 7, as amended, and K.C.C. 2.49.060, Ordinance 14482, Section 9, and K.C.C. 2.49.080, Ordinance 14482, Section 11, and K.C.C. 2.49.110, Ordinance 14482, Section 17, and K.C.C. 2.49.160, Ordinance 14482, Section 18, as amended, and K.C.C. 2.49.170, Ordinance 14482, Section 19, and K.C.C. 2.49.180, Ordinance 14440, Section 3, and K.C.C. 2.49.200, Ordinance 14482, Section 58, as amended, and K.C.C. 4.40.015 and Ordinance 17527, Section 57, as amended, and K.C.C. 4.40.110, adding a new section to K.C.C. chapter 2.49, decodifying K.C.C. 2.49.070 and repealing Ordinance 14482, Section 10, and K.C.C. 2.49.090.

Mary Bourguignon, Council staff, provided a brief overview to the Committee and answered questions from the members. Councilmember Upthegrove moved striking amendment S1.2. Councilmember Dembowski moved amendment 1 to striking amendment S1.2. Councilmember Kohl-Welles moved withdrawal of striking amendment S1.2 and suspension of the rules under rule 18.b. in favor of striking amendment S3. Kendall Moore, Deputy Chief Legal Council, addressed the Committee and answered questions from the members. The motion failed. Amendment 1 passed with a vote of 5 Ayes and 4 Noes (Councilmembers Balducci, Lambert, Kohl-Welles and McDermott).

Councilmember Upthegrove moved amendment 2 to striking amendment S1.2. Amendment 2 was adopted unanimously.

Councilmember McDermott moved amendment 3 to striking amendment S1.2. Amendment 3 was adopted by a vote of 5 Ayes and 4 Noes (Councilmembers Lambert, Dunn, Upthegrove and Gossett). Councilmember Kohl-Welles moved amendment 4 to striking amendment S.1. Being on the prevailing side, Councilmember von Reichbauer moved for reconsideration of amendment 3. Jim Brewer, Legal Council, addressed the Committee and answered questions from the members. Councilmember Kohl-Welles withdrew amendment 4. The vote to reconsider amendment 3 passed by a vote of 5 Ayes and 4 Noes (Councilmembers Kohl-Welles, McDermott, Balducci and Dembowski). Councilmember McDermott moved amendment 3 to striking amendment S1.2. The amendment failed under reconsideration with a vote of 4 Ayes and 5 Noes (Councilmembers Gossett, Lambert, von Reichbauer, Dunn and Upthegrove).

Councilmember Kohl-Welles moved amendment 4 to striking amendment S1.2. Amendment 4 failed by oral vote.

Councilmember Lambert moved amendment 5 to striking amendment S1.2.

Amendment 5 failed by a vote of 4 Ayes and 5 Noes (Councilmembers Dunn, Gossett, Lambert, Upthegrove and von Reichbauer.

Councilmember Kohl-Welles moved amendment 6 to striking amendment S1.2. Amendment 6 failed by oral vote.

Amendment S1.2 as amended was adopted with a vote of 5 Ayes and 4 Noes

(Councilmembers Kohl-Welles, Lambert, McDermott and Balducci).

Councilmember Upthegrove moved title amendment T1. Amendment T1 was adopted.

A motion was made by Councilmember Upthegrove that this Ordinance be Recommended Do Pass Substitute. The motion carried by the following vote:
