2	approximately 35.71 acres of land into the Soos Creek
3	Water and Sewer District for the purpose of providing

7	STATEMENT OF FACTS:
8	1. A notice of intention proposing the annexation of approximately 35.71
9	acres of land into the Soos Creek Water and Sewer District for the purpose
10	of providing sewer service for future development was filed with the
11	county council on March 8, 2005.
12	2. Soos Creek Water and Sewer District has found the petition for transfer
13	to be sufficient and has concurred with the proposed transfer in Resolution
14	No. 2673-S, passed on January 5, 2005.
15 .	3. Soos Creek Water and Sewer District adopted Resolution 2672-S a
16	Determination of Nonsignificance on the proposed annexation on January
17	5, 2005.

18	4. The utilities technical review committee recommended county council
19	approval of the proposed annexation.
20	5. The county council held the legally required public hearing and has
21	considered the criteria in RCW 57.02.040.
22	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
23	SECTION 1. The annexation of approximately 35.71 acres of into Soos Creek
24	Water and Sewer District for the purpose of providing sewer service for future
25	development described in Attachment A of this ordinance is approved. Approval of this
26	proposed annexation is consistent with RCW 57.02.040.
27	SECTION 2. Soos Creek Water and Sewer District is the appropriate entity to
28	serve the area proposed to be annexed.

29 SECTION 3. SOOS CREEK WATER & SEWER DISTRICT ANNEXATION P364S LEGAL DESCRIPTION

2005-108

BEGINNING at the intersection of the West margin line of the 200-foot Burlington Northern Railroad Company right-of-way and the North line of the Southeast quarter of the Southeast quarter of Section 34, Township 22 North, Range 6 East, W.M., in King County, Washington, said point being on the existing corporate boundary of Soos Creek Water & Sewer District;

Thence Southerly along said West margin line to its intersection with the South line of said Southeast quarter of the Southeast quarter of Section 34;

Thence Westerly along said South line to its intersection with the West line of the East half of the Southwest quarter of said Southeast quarter of Section 34;

Thence Northerly along said West line to its intersection with the North line of said Southwest quarter of the Southeast quarter of Section 34, said point being on the existing corporate boundary of Soos Creek Water & Sewer District;

Thence Easterly along said North line and the North line of the Southeast quarter of said Southeast quarter of Section 34, to its intersection with the West margin line of the 200-foot Burlington Northern Railroad Company right-of-way and the POINT OF BEGINNING of this description.
