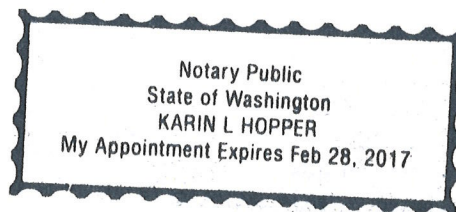

PROJECT NAME: Ordinance No. 643 Zoning Code Administrative Procedures

DESCRIPTION OF PROPOSAL: Ordinance No. 643 would establish Chapter 21.61, revise Chapters 21.80, 21.84, 21.85, and 21.86 of the Woodinville Municipal Code. This change will revise the decision criteria for permit approvals, application submittal requirements, permit types, noticing procedures, appeal procedures, subdivision procedures, and hearing procedures.

LOCATION OF PROPOSAL, INCLUDING STREET ADDRESS, IF ANY: Citywide

LEAD AGENCY: City of Woodinville

The lead agency for this proposal has determined that it does not have a probable significant adverse impact on the environment.
