1 AN ORDINANCE increasing the filing fees for all
2 mandatory arbitration and trial de novo of an arbitration
3 award cases in superior court under RCW 36.18.016 filed
4 on or after September 1, 2018; and amending Ordinance
5 13842, Section 2, as amended, and K.C.C. 4A.630.070 and
6 Ordinance 13563, Section 2, and K.C.C. 4A.630.080.

7 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

8 SECTION 1. A. Section 2 of this ordinance increases the fee for filing a request
9 for mandatory arbitration.

10 B. This increase is authorized under RCW 36.18.016 and Section 8, Chapter 36,
11 Laws of Washington 2018, which allows counties to impose a fee for filing a request for
12 mandatory arbitration.

13 SECTION 2. Ordinance 13842, Section 2, as amended, and K.C.C. 4A.630.070
14 are each hereby amended to read as follows:

15 Mandatory arbitration request. The department of judicial administration is hereby
16 authorized to assess and collect a fee for filing a request for mandatory arbitration, as
17 authorized in RCW 36.18.016. The fee will be two hundred ((twenty)) fifty dollars.

18 SECTION 3. A. Section 4 of this ordinance increases the fee for filing a request
19 for trial de novo of an arbitration award.

20 B. This increase is authorized under RCW 36.18.016, which allows counties to
21 impose a fee for filing a request for a trial de novo of an arbitration award.

22 SECTION 4. Ordinance 13563, Section 2, and K.C.C. 4A.630.080 are each
23 hereby amended to read as follows:

24 Trial de novo of arbitration award. The department of judicial administration is
25 hereby authorized to assess and collect a fee for filing a request for a trial de novo of an

26 arbitration award, as authorized under RCW 36.18.016. The fee shall be ~~((two))~~ four
27 hundred ~~((fifty))~~ dollars.


