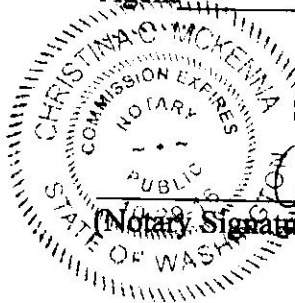



A public hearing will be held upon said application before the Metropolitan King County Council in Room 1001, King County Courthouse, Seattle, Washington, on the 17th day of February, 2015 at 1:30 P.M. The following is a legal description of the area:

LEGAL DESCRIPTION OF PROPOSED FRANCHISE AREA WHICH DESCRIBES THE PLAT OF BARING RECORDED JUNE 10, 1901, #210776 IN VOLUME 9 OF PLATS PAGE 86.

SECTION 2, TOWNSHIP 26 NORTH, RANGE 10 EAST, BEGINNING AT THE QUARTER SECTION CORNER ON THE NORTH BOUNDRY OF SECTION 2, AND RUN SOUTH ON RANDOM QUARTER SECTION LINE 1410', TO THE BEGINNING OF THE SURVEY, THEN SOUTH 29' THEN SOUTH 41 DEGREES 56 MINUTES EAST, 1120', THEN NORTH 48 DEGREES 04 MINUTES EAST, 398', THEN NORTH 41 DEGREES 56 MINUTES WEST, 1140', THEN SOUTH 48 DEGREES 04 MINUTES WEST 378' TO PLACE OF BEGINNING.
