1 AN ORDINANCE reflecting revised due dates for  
 2 submission to council of the implementation plan of the  
 3 revised human services policy framework  
 4 recommendations outlined in the 2007 Human Services  
 5 Recommendations Report and the veterans and human  
 6 services levy quarterly progress report; and amending the  
 7 2009 Budget Ordinance, Ordinance 16312, Sections 69, 70  
 8 and 87, as amended.

10 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

11 SECTION 1. Ordinance 16312, Section 69, is hereby amended by adding thereto  
12 and inserting therein the following:

13 VETERANS AND FAMILY LEVY - From the veterans and family levy fund  
14 there is hereby appropriated to:

15 Veterans and family levy 0

16 The maximum number of FTEs for veterans and family levy shall be: 0

17 P1 PROVIDED THAT:

18           Of this appropriation, \$100,000 shall not be expended or encumbered until the  
19 executive submits four quarterly progress reports for the veterans and human services.  
20 The quarterly reports shall include at a minimum: the amount of funding expended to  
21 date, the amount of funding contracted to date, the number and status of request for  
22 proposals to date and any individual program statistics available, such as number of  
23 individuals served. The quarterly reports are due on March 1, (~~June~~) July 1, September  
24 1 and December 1, 2009, for council review.

25           Twelve copies of each report must be filed with the clerk of the council, who shall  
26 retain the original and will forward copies to each councilmember and to the lead staff  
27 the law, justice and human services committee and the regional policy committee, or their  
28 successors.

29           SECTION 2. Ordinance 16312, Section 70, as amended, is hereby amended by  
30 adding thereto and inserting therein the following:

31           HUMAN SERVICES LEVY - From the human services levy fund there is hereby  
32 appropriated to:

34           The maximum number of FTEs for human services levy shall be:	0

35           ER1 EXPENDITURE RESTRICTION:

36           Of this appropriation, \$225,893 shall be expended solely for family treatment  
37 court.

38           P1 PROVIDED FURTHER THAT:

39           Of this appropriation, \$100,000 shall not be expended or encumbered until the  
40 executive submits four quarterly progress reports for the veterans and human services

41 levy. The quarterly reports shall include at a minimum: the amount of funding expended  
42 to date, the amount of funding contracted to date, the number and status of request for  
43 proposals to date and any individual program statistics available, such as number of  
44 individuals served. The quarterly reports to the council are due on March 1, (~~June~~) July  
45 1, September 1 and December 1, 2009, for council review.

46 Twelve copies of each report shall be filed with the clerk of the council, who shall  
47 retain the original and must forward copies to each councilmember and to the lead staff  
48 the law, justice and human services committee and the regional policy committee, or their  
49 successors.

50 SECTION 3. Ordinance 16312, Section 87, as amended, is hereby amended by  
51 adding thereto and inserting therein the following:

52 CHILDREN AND FAMILY SERVICES COMMUNITY SERVICES -  
53 OPERATING - From the children and family services fund there is hereby appropriated  
54 to:

56	The maximum number of FTEs for children and family services community services -	
57	operating shall be:	0

58 P1 PROVIDED THAT:

59 Of this appropriation, \$100,000 shall not be expended or encumbered until the  
60 executive submits and the council accepts by motion a report on the implementation of  
61 the revised human services policy framework recommendations outlined in the 2007  
62 Human Services Recommendation Report. The report shall include at least:

63           1. A status report, timeline and milestones on the implementation of King  
64 County's framework policies for human services since August 2007;

65           2. A status report on the activities and actions of the department of community  
66 and human service's implementation of the county auditor's 2006 performance audit  
67 recommendations on human services contracting practices. The report shall include the  
68 number and status of request for proposals that the department of community and human  
69 services has conducted since August 2007 and expects to conduct in 2009 for 2010  
70 funding. The request for proposal list contained in the report shall specify program area,  
71 scope of work, priority areas, available funds, funding source or sources, award amounts,  
72 if known, and what entity performed the work in the past. The department shall also  
73 identify how, and on what policy basis, it developed its request for proposal evaluation  
74 criteria that assigns value for specific geographic areas or populations served; and

75           3. A description of the department's criteria and process for recommending  
76 program reductions resulting from reduced budget allocations. The department shall  
77 identify how program reductions are aligned with identified county policy directives such  
78 as the juvenile justice operational master plan, veterans and human services levy or the  
79 mental illness and drug dependency action plan.

80           This report is due to the council on or before ((June)) July 1, 2009. Eleven copies  
81 of the report must be filed with the clerk of the council, who shall retain the original and  
82 will forward copies to each councilmember and to the lead staff of the committee of the  
83 whole, or its successor.

84           P2 PROVIDED FURTHER THAT:

85           Of this appropriation, \$5,907,158 shall be expended solely for contracts with the  
86 agencies and in the amounts listed below. For contracts that were included in the  
87 executive's 2009 proposed budget, a variance of up to ten percent from the amounts  
88 listed below may be adjusted administratively without council approval. The quarterly  
89 financial reports shall include a table of all contracts listed here showing any adjustments.
