1 AN ORDINANCE establishing February 11, 2014, as the
2 date of a special election on the question of annexation to
3 the city of Issaquah, and assumption of indebtedness, of an
4 unincorporated area known as the Klahanie annexation area
5 and appointing a committee to write the voters' pamphlet
6 statement for the February 11, 2014, special election; and
7 declaring an emergency.

8 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

9 SECTION 1. Findings:

10 A. The city of Issaquah, Washington, by Resolutions No. 2013-07 and 2013-20,
11 has determined that it is in the public interest and general welfare to provide for the
12 annexation of for the annexation of an area known as the Klahanie annexation area, in
13 accordance with chapter 35A.14 RCW.

14 B. City of Issaquah Resolutions No. 2013-07 and XXX satisfy the provisions of
15 chapter 35A.14 RCW for qualification for annexation.

16 C. The King County boundary review board received a request for review under
17 chapter 36.93 RCW, and on November 6, 2013, the board, in file 2347, deemed the
18 proposed city of Issaquah Klahanie annexation file approved.

19 D. The statutory deadline for placing such a proposition on the February 11, 2014
20 ballot is December 27, 2013. The last council meeting of 2013 is a special meeting on
21 December 16, 2013.

22 E. Pursuant to chapters 29A.04 and 35A.14 RCW, the metropolitan King County
23 council deems an emergency exists for the purpose of calling a special election to be held
24 on the question of this annexation on February 11, 2014.

25 SECTION 2. A special election shall be held on the 11th day of February 2014 in
26 accordance with chapter 35A.14 RCW within the territory of the proposed annexation,
27 Attachment A to this ordinance, for the purpose of submitting the question of annexation
28 of the Klahanie annexation area and whether or not all property in the annexation area
29 will assume its proportional share of existing city bonded indebtedness.

30 SECTION 3. The number of registered voters within the subject area is estimated
31 at 6,450 as nearly as may be determined from available records.

32 SECTION 4. Pursuant to RCW 29A.04.321 and 35A.14.050, it is hereby deemed
33 that an emergency exists for purposes of calling a special election. The King County
34 elections director is hereby requested to assume jurisdiction to call and conduct a special
35 election and submit to the registered voters within the subject area of the proposition as
36 set forth in section 4 of this ordinance. The clerk of the council is hereby authorized and
37 directed to transmit the proposition to the elections director in substantially the following
38 form, with such additions, deletions or modifications in the ballot title as may be required
39 for the propositions listed below by the King County prosecuting attorney:

40 Proposition 1: Klahanie Annexation Proposal

41 Shall the Klahanie Annexation Area be annexed to
42 the City of Issaquah?

43 For annexation, adoption of proposed zoning regulations and
44 assumption of proportionate share of then-outstanding indebtedness.

45 Against annexation, adoption of proposed zoning regulations
46 and assumption of proportionate share of then-outstanding indebtedness.

47 SECTION 5. The director of elections is hereby authorized and requested to
48 prepare and distribute a local voters' pamphlet, pursuant to K.C.C. 1.10.010, for the
49 special election called for in this ordinance, the cost of the pamphlet to be included as
50 part of the special election.

51 SECTION 6. A certified copy of this resolution shall be transmitted to the King
52 County records, elections and licensing services division.

53 SECTION 7. The county council finds as a fact and declares that an emergency
54 exists and that this ordinance is necessary for the immediate preservation of public peace,

55 health or safety or for the support of county government and its existing public
56 institutions.

**ANNEXATION
KLAHANIE
Legal Description**

That portion of Sections 10, 11, 12, 13, 14, 15, 22 and 23 Township 24 North, Range 6 East, W.M., King County, Washington, described as follows:

Beginning at the intersection of the West line of the East half of the Northeast quarter of said Section 22, and the Easterly line of the Plat of Vaughn Hill Addition as recorded in Volume 102 of Plats, Pages 99-100, records of King County, Washington, said intersection being on the Issaquah city limits as annexed under Ordinance No. 2255;

Thence along said Issaquah city limits, Southeasterly along said Easterly line to the intersection with the Southerly line of Tax Lot 222406-9079, as further described below;

Thence leaving said Issaquah city limits, Northeasterly along said Southerly line to its intersection with the Easterly line of said Tax Lot;

Thence Northwesterly along said Easterly line to the intersection of the Southwesterly extension of the Southerly line of Tax Lot 222406-9080, as further described below;

Thence Northeasterly along said extension and Southerly line to the intersection of the Southerly boundary of Tax Lot 222406-9094, further described below;

Thence Northeasterly along said Southerly boundary to the intersection of the Easterly line of said Tax Lot;

Thence Northerly along said Easterly line to the intersection with the Southeasterly margin of Issaquah-Fall city Road as conveyed to King County under King County recording number 9807070554;

Thence Northeasterly along said Southeasterly margin to its intersection with the Southwesterly extension of the Southeasterly margin of SE Duthie Hill Road;

Thence Northeasterly along said Southeasterly margin to its intersection with the Southeasterly extension of the Southwesterly margin of Issaquah-Beaver Lake Road, said intersection being on the Sammamish city limits as established by the incorporation of the city of Sammamish;

Thence along said Sammamish city limits the following courses:

Thence Northwesterly along said extension and said Southwesterly margin to its intersection with the South margin of SE 32nd Street;

Thence Westerly along said South margin to its intersection with the Southeasterly margin of SE 32nd Way;

Thence Southwesterly along said Southeasterly margin to its intersection with the Easterly margin of Issaquah-Pine Lake Road (also known as Gobel Road, King County Road No. 558) as established by deed recorded under King County recording number 7807130727;

Thence Southeasterly, Southwesterly, Southerly and Southeasterly along said Easterly margin to its intersection with the Easterly extension of the South margin of SE 48th Street, said intersection being on the Issaquah city limits as annexed under said Ordinance No. 2255;

Thence leaving said Sammamish city limits and following said Issaquah city limits the following courses:

Thence continue Southwesterly along said Easterly margin to its intersection with the Northwesterly margin of said Issaquah-Fall city Road as conveyed to King County under King County recording numbers 9807070556 and 9807070557;
Thence Northeasterly along said Northwesterly margin to the West line of the East Half of the Northeast quarter of said Section 22;
Thence Southerly along said West line to the **Point of Beginning**.
