B. HISTORY AND OVERVIEW

R.C.W. 36.87 establishes the right of property owners to petition a county legislative body for the vacation of road rights-of-way. K.C.C. 14.40 establishes King County policies and procedures for accomplishing same.

The petition was filed with the Clerk of the King County Council on September 17, 2021, by Drake Randle and William and Vikki Johnson seeking the vacation of a portion of 43rd Ave S.in the Auburn area of unincorporated King County.

King County acquired the subject right-of-way by dedication in the Plat of Camelot, Division G, recorded in Volume 77 of Plats, Pages 17 and 18, recording number 196501125831676, records of King County. Exhibit 5. The plat dedicates to the use of the public forever, all streets, avenues and easements shown thereon, and the use thereof for all public purposes not inconsistent with the use thereof for public highway purposes.

The subject portion of right-of-way qualifies as open, improved, and maintained county road.

C. NOTICE

Notice of this hearing was posted at the approximate ends of the proposed vacation area on June 21, 2024, see Exhibit 17, and published in accordance with requirements of RCW 36.87.060. See Exhibit 18.

D. REVIEWING AGENCIES AND COMMENTS

The King County Department of Local Services, Road Services Division ("Roads") solicited comments from agencies within King County and utilities serving the area regarding the impacts of vacating the subject area. The responses received are listed below. Puget Sound Energy ("PSE') identified lines within the vacation area and Roads' Drainage Unit identified a 24' storm drain within the area. PSE and Roads will need easements if the vacation is approved. No other utility or agency identified infrastructure within the subject right-of-way or requested an easement over the vacation area.

Roads did not receive responses from Lakehaven Water and Sewer District, and the following King County agencies: Executive Services, Division of Real Estate Services and Historical Preservation; Department of Natural Resources and Parks, Open Space and Wastewater Divisions; Metro Transit: and the Department of Local Services Road Services Division Archeologist. A copy of the Notice is included as Exhibit 9.

5.	DLS Permitting	Response dated 11/22/2021. It may be premature to vacate this portion of 43 rd Ave S., as it provides access to Camelot Park (pedestrian, maintenance) as well as may provide an informal walking path to Camelot Elementary (southwest), based on imap aerial. If King County Parks (DNRP) and the School District do not object to the vacation, then Permitting Division has no further objection.
6.	DNRP – Parks	Response dated 8/26/2022. ROW is necessary or useful for current or future trail. Current Park in the vicinity. Preserve all or portion of ROW and this is the only public access to Camelot Park.
7.	DNRP – Water and Land Resources Division	Response dated 6/2/2022. WLRD has no assets out here but I do see that there is some Roads ROW drainage that sits within the proposed vacation. Response 11/16/2021 from River and Floodplain Mgmt Section – No concerns.

8.	DLS Roads- CIP & Planning Section	Response dated 12/17/2021. 07/13/2021. We have no long-range transportation planning concerns about this road vacation, if one or both of the following is true: • Current trail access to Camelot Park at the road vacation site will be maintained • There are alternative access points available from the Camelot Park trail system to reach S 294 th Street to the north that provide similar access for students This road vacation is a dead-end paved street between two homes and connects to a trailhead entering Camelot Park to the South. S 294th Street, which this dead-end street connects to just north, is a King County local roadway with a TNR, long-range transportation need identified for a nonmotorized improvement. The source of this project is the need to serve students that walk to/from school. It also appears to have a transit route and multiple stops along its length. Camelot Park, per conversation with Parks staff, is mainly used for students walking to/from school. If this road vacation cuts off park access at that point, the question is whether or not there is an alternative for students to walk between Camelot Park and S 294th Street. There appears to be another access point a few blocks east, but the condition of trails within the park, and which access points are typically used by students, is unknown (by me). Parks staff would be in the best position to weigh in on the park trails, student use, and the relative importance of this particular trailhead/road vacation site for students.
9.	DLS Roads Maintenance Section	Response dated 11/16/2021. Roads has drainage in that road section that will need to be maintained.
10.	DLS Roads- Traffic Engineering	Response dated 11/17/2021. Traffic Engineering would have no objection to this proposed right-of-way vacation. Additional Response dated 11/16/2021. This piece of 43 rd Ave SE provides one of the few access points to a large neighborhood greenspace owned by DNRP. It may be difficult to maintain that access via an easement

11.	DLS Roads – Survey	Response dated 12/23/2021. ROW Does not appear to be needed as it is one of several short r/w connections in the immediate area to the KC Camelot Park-forested land to the immediate south of property. This area is set aside as public open space and has several adequate, existing street access points. Recommendation - Approve, with any needed/requested easements
12.	DLS Roads Environmental Unit	Response dated 12/14/2021. The RSD Environmental Unit has no objections to this proposed road vacation, but this portion of ROW provides public access to Camelot Park, a King County open space. King County iMap shows a large wetland and stream within the park boundaries adjacent to this portion of ROW, and the ROW is likely within the critical area buffer of these features. The petitioners should be made aware of development restrictions within wetland and stream buffers at KCC 21A.24.335 and 21A.24.365, respectively.
13.	DLS Roads Drainage	Response dated 04/22/2022. The right-of-way is necessary, required for 24" diameter storm drainage outfall system. Also provides access to King County Park, and there appears to be a trail entering the park from the end of this road. At a minimum we will need a 20' wide easement to maintain the stormwater system. Not likely the public will be benefited from the vacation as it will eliminate access to the public park. Recommendation – do not vacate.

E. COMPENSATION

Utilizing the model prepared by King County Office of Performance, Strategy and Budget (PSB), Roads solicited from the Assessor's Office a determination of value for the vacation area that will attach to the property owned by Petitioners. See Exhibit 10.

If the petition is approved, the property of Petitioner Drake Randle, parcel number 1311600370, will receive approximately 2,667 square feet. The Assessor's Office determined that adding 6,250 square feet to the property would result in no change in value. Therefore, if the petition is approved, no addition compensation would be required. See Exhibit 12.

Similarly, if the petition is approved, the property of Petitioners William and Vikki Johnson, parcel number 1311600360, will also receive approximately 2,667 square feet. The Assessor's Office determined that adding 6,250 square feet to the property would result in no change in value. Therefore, if the petition is approved, no addition compensation would be required. See Exhibit 11.

F. COUNTY ROAD ENGINEER RECOMMENDATION

The County Road Engineer has determined that the subject portion of right-of-way remails useful and necessary to the county transportation system providing public access to public property and that petition V-2750 should be denied.

However, should the petition be approved, then, consistent with the application of the PSB compensation model as applied to this road vacation petition, the subject portion of right-of-way be vacated without the condition of payment of additional compensation by the Petitioners. The full County Road Engineer's Report is attached as Exhibit 14.

Leslie – a bit more context for my previous email...

This road vacation is a dead end paved street between two homes, and connects to a trailhead entering Camelot Park to the South. S 294th Street, which this dead end street connects to just north, is a King County local roadway with a TNR, long-range transportation need identified for a nonmotorized improvement. The source of this project is the need to serve students that walk to/from school. It also appears to have a transit route and multiple stops along it's length.

Camelot Park, per conversation with Parks staff, is mainly used for students walking to/from school. If this road vacation cuts off park access at that point, the question is whether or not there is an alternative for students to walk between Camelot Park and S 294th Street. There appears to be another access point a few blocks east, but the condition of trails within the park, and which access points are typically used by students, is unknown (by me).
