1 AN ORDINANCE approving the Lakehaven Utility District
2 2006 Water System Plan.

4 **STATEMENT OF FACTS:**

5 1. King County has adopted K.C.C. chapter 13.24, which requires
6 approval of comprehensive plans for water utilities that distribute or obtain
7 water in unincorporated King County as a prerequisite for operating in
8 unincorporated King County, receiving approval for annexation proposals,
9 being granted right-of-way franchises and being given approval for right-
10 of-way construction permits. K.C.C. 13.24.060 prescribes the
11 requirements for approval of such plans, including consistency with state
12 and local planning requirements.

13 2. RCW 57.16.010 requires that general comprehensive plans for water
14 districts must be submitted to and approved by the legislative authority
15 within whose boundaries all or a portion of the district lies.

16 3. King County last approved the Lakehaven Utility District Water
17 System Plan ("the plan") in 1999. Both Washington state Department of

18 Health and King County regulations require water system plans to be
19 updated every six years; the district has been pursuing an update of the
20 plan for the past few years.

21 4. The Lakehaven utility district ("the district") is in King County and has
22 adopted a 2006 water system plan.

23 5. King County has adopted a comprehensive plan that includes water
24 supply policies in its provisions for facilities and services (policies F-213
25 through F-245) that call for consistency with other adopted plans, support
26 for regional water supply planning, pursuit of reclaimed water and water
27 conservation and protection of water resources.

28 6. K.C.C. chapter 13.24 requires review of water system plans by the
29 utilities technical review committee ("UTRC"), and a recommendation
30 made to the King County executive and council on the plan and the
31 requirements under K.C.C. chapter 13.24 and consistency with the King
32 County Comprehensive Plan. The utilities technical review committee has
33 reviewed the planning data and district operations and hereby finds:

34 a. The plan is consistent with population and employment forecasts
35 developed by the Puget Sound Regional Council for the district's service
36 area, with a customized forecast appropriately used;

37 b. The plan appropriately uses King County land use classifications;

38 c. The capital facility plan is adequate to meet anticipated facility and
39 service needs;

40 d. The plan is consistent with applicable state water quality laws,
41 including the evaluation of reclaimed water use; and

42 e. The plan is consistent with other pertinent county adopted plans and
43 policies.

44 7. The Washington state Department of Health approved the district's
45 water plan on October 15, 2008.

46 8. The district completed a state Environmental Policy Act checklist and
47 issued a determination of nonsignificance for the issuance of the plan on
48 October 12, 2006.

49 9. The district's operations and facilities meet multiple existing statutory,
50 administrative, and planning standards. As the district's operations,
51 facilities, and planning meet the requirements of the King County Code
52 and are consistent with the King County Comprehensive Plan, the utilities
53 technical review committee recommends approval of the plan.

54 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

55 SECTION 1. The Lakehaven Utility District 2006 Water System Plan,

58 plan.


