Proposed No. 2008-0577.1 Sponsors Phillips 1 AN ORDINANCE relating to sheriff's civil unit fees: and 2 amending Ordinance 14792, Section 2, and K.C.C. 3 4.104.010. 4 5 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY: 6 SECTION 1. A. Section 2 of this ordinance proposes changes to the civil process 7 fees to cover cost increases in administration and operation of the sheriff's civil unit. 8 B. These fees are assessed under RCW 36.18.040(1), which sets the base level 9 fees that sheriff's collect for their official services. The fees have not been adjusted for 10 five years. 11 C. County legislative authorities may adjust the fees to cover the costs of 12 administration and operation under RCW 36.18.040(3). 13 SECTION 2. Ordinance 14792, Section 2, and K.C.C. 4.104.010 are each hereby 14 amended to read as follows: 15 The following fees apply as provided in this chapter: 16 A. Service of civil process, service, summons and complaint, notice and 17 complaint, summons and petition and notice of small claim:
