**Ordinance 19128**

NOTICE IS HEREBY GIVEN that the Metropolitan King County Council (the Council) held a public hearing remotely in compliance with the Washington State Governor's Declaration 20-29 (or as amended) regarding the Open Public Meetings Act on Tuesday, July 7, 2020, beginning at 1:00 PM. The purpose of this public hearing was to consider adoption of Proposed Ordinance 2020-0045 (Ordinance 19128), an ordinance relating to the County's zoning code. The Council then adopted this Ordinance at the same meeting.

**SUMMARY:**

Ordinance 19010 amends the King County Zoning Code to update floodplain development regulations to meet federal and state minimum floodplain management standards, to ensure consistency within King County regulations, and to make technical, clarifying, and administrative changes.
