NOTICE IS HEREBY GIVEN that a public hearing will be held before the Metropolitan King County Council on the 14th day of December, 2021, at 1:00 p.m., to consider adoption of Proposed Ordinance 2021-0356, to approve an application for renewal of a franchise with Sprint Communications Company L.P., for use of certain road rights-of-way in unincorporated King County for the construction, operation, and maintenance of wireline telecommunications transmission facilities. The public hearing is planned to either be held at the King County Courthouse, 516 3rd Avenue, Room 1001, Seattle, Washington; or the hearing may be required to be held remotely to comply with the Washington State Governor's Declaration 20-28 (or as amended) regarding the Open Public Meetings Act. Information on this public hearing, including how to submit public testimony and attend the meeting, will be posted on the Council's website ahead of the hearing.

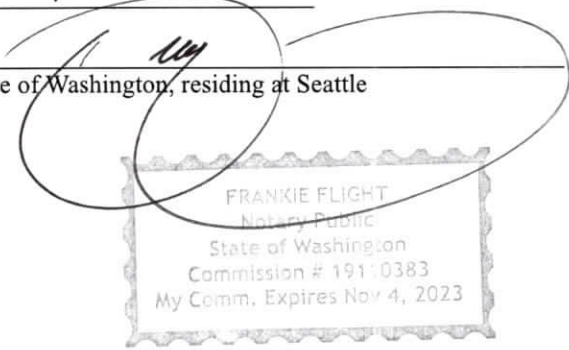
