NOTICE IS HEREBY GIVEN that a public hearing will be held before the Metropolitan King County Council on the 23rd day of November, 2021, at 1:00 p.m., to consider adoption of Proposed Ordinance 2021-0374, relating to the repeal of fees for disposal of court exhibits charged by the department of judicial administration. The public hearing is planned to either be held at the King County Courthouse, 516 3rd Avenue, Room 1001, Seattle, Washington; or the hearing may be required to be held remotely to comply with the Washington State Governor's Declaration 20-28 (or as amended) regarding the Open Public Meetings Act. Information on this public hearing, including how to submit public testimony and attend the meeting, will be posted on the Council's website ahead of the hearing.

**SUMMARY**  
Proposed Ordinance 2021-0374 repealing a fee for the disposal of court exhibits not withdrawn by the parties forty-five to ninety days following case completion. This fee is assessed in accordance with RCW 36.18.016(11) for a cost of thirty dollars.

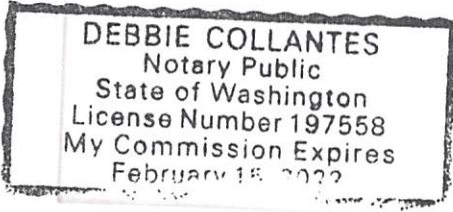
