ORDINANCE 19721 NOTICE IS HEREBY GIVEN, that a public hearing before the Metropolitan King County Council will be held at the King County Council will be held at the Avenue Room 1001 on the 6th day of February, 2024, at 1:30 p.m. to receive public testimany relating to Ordinance 19721, which adopted findings in support of, and adopted for ane year, a morato-rium prohibiting the acceptance of applications for the establishment of new or expansion of existing wineries, breweries, distilleries, and remote tasting rooms, as primary or accessory uses or as home occupations or home industries; and prohibiting temporary use permits for wineries, breweries, distilleries, and remote tasting rooms, and establishing a work plan.

Remote public testimony on Zoom will also be accepted. Information on the public hearing and how to submit public testimony can be found at this website: https://kingcounty.gov/en/legacy/counc il/committees/full_council.aspx.

Background Ordinance 19309 was adopted on Decem-ber 12, 2023. A public hearing within 60 days of enactment of a moratorium is required by RCW 36.70A.390. This hear-ing is the opportunity for public testi-mony on the moratorium.
