11 change the name of the district from King County fire protection district
12 38 to "Fire District 38."


WHEREAS, King County Fire Protection District #38, King County, North Bend/Snoqualmie, Washington, has at all times in its existence been known by such name; and

WHEREAS, it is in the best interests of the Fire District to change its name to "Fire District 38", and


WHEREAS, RCW 52.30.060 provides a procedure for a fire protection district to change its name,

Adopted at the regular meeting of the Board of Commissioners for King County Fire Protection District 38 this 10th day of January, 2006.




