The purpose of this public hearing was to consider adoption of Proposed Ordinance 2018-0068 (Ordinance 18683) an ordinance relating to the County's development regulations.

**SUMMARY:**

Ordinance 18683 amends the King County development regulations to replace gendered pronouns and historically gendered terms with gender neutral terms.
