A. and B. of Ordinance 17178 enact a one-year moratorium commencing upon the date of adoption of this ordinance and is declared on the issuance of new public amusement/entertainment licenses required under K.C.C. 6.08.020 and the establishment of new music and dance entertainment venues proposed within the commercial zoned land of North Highline subject to the economic redevelopment special district overlay authorized by K.C.C. 21A.38.090. Ordinance 17178 was passed by the Council on August 29, 2011. The public hearing on the moratorium is being held as required by the Growth Management Act, chapter 36.70A RCW.
