1 AN ORDINANCE relating to the county property tax
2 levies for collection in 2014, implementing RCW
3 84.55.120; and amending Ordinance 17694, Section 2.

4 PREAMBLE:

5 Ordinance 17694 authorized property tax changes for collection in 2014.
6 However, the new voter-approved parks levy, under Ordinance 17568,
7 was erroneously listed separately instead of being included in the county's
8 regular levy. Moreover, the estimated levy amounts were not revised to
9 reflect the most recent assessed values available.

10 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

11 SECTION 1. Ordinance 17694, Section 2 is hereby amended to read as follows:

12 For collection of the property tax levies in 2014, the council hereby authorizes
13 property tax changes compared to the amounts authorized for collection in 2013 as
14 follows:
